Occasionally, you may want to condense several citations into one, especially if multiple sources share a singular viewpoint and are saying the same thing. If done correctly, this can save space and can help your writing to flow better without having to break it up with multiple citations for sources that are essentially saying the same thing. Be careful to only include citations that support your immediate point. This method is sometimes referred to as a citation string. The citations should be listed alphabetically with semicolons separating them, like this example (Author A's Last Name, Year; Author B's Last Name et al., Year; Author C's Last Name, Year).

Level 1 Headings Are Centered, Bolded, and Written in Title Case

Level 1 is the highest or main level of heading. Use only the number of headings necessary to differentiate distinct sections in your paper; short student papers may not require any headings at all. Additionally, be sure to avoid these four common errors related to headings: avoid having only one subsection heading within a section; just like in an outline, do not label headings with numbers or letters; double-space headings (do not switch to single spacing within headings); and do not add blank lines above or below headings, even if a heading falls at the end of a page.¹

Level 2 Headings Are Left-Justified, Bolded, and Written in Title Case

Level 2 is a subheading of level 1, and the paragraph text starts on the next line.² Words are used to express numbers zero through nine in the text, including the abstract, and any number that begins a sentence, title, or heading (when possible, reword the sentence to avoid beginning

with a number). Use numerals when expressing numbers 10 and above; numbers immediately preceding a unit of measurement; numbers representing statistical or mathematical functions, fractional or decimal quantities, percentages, ratios, and percentiles and quartiles; and numbers representing time, dates, ages, scores and points on a scale, exact sums of money, and numerals as numerals.

Level 3 Headings Are Left-Justified, Bolded, Italicized, and Written in Title Case

Level 3 is a subheading of level 2, and the paragraph text starts on a new line. Lists help readers understand a related set of key points within a sentence or paragraph. When a list within a sentence contains three or more items, use the serial comma before the final item. However, if any item in a list of three or more items already contains commas, use semicolons instead of commas between the items. Lettered lists may also be used to draw attention to items, but not as much attention as a numbered or bulleted list. Use commas or semicolons between items.

Use a numbered list to display complete sentences or paragraphs in a series. Use the numbered list function of your word-processing program to create the numbered list; this will automatically indent as well. Select the option for Arabic numeral followed by a period but not enclosed in or followed by parentheses. Capitalize the first word after the number (and the first words in any subsequent sentence), and end each sentence with a period or other punctuation as appropriate.

Numbered lists may connote an unwanted or unwarranted ordinal position among the items. Use bullets to identify items in a series to achieve the same effect as numeral lists without the implication of ordinality. Use the bulleted list function of your word-processing program to create the bulleted list; this will automatically indent the list as well. Symbols such as small circles, squares, dashes, and so forth may be used for the bullets. If bulleted list items are

complete sentences, begin each sentence with a capital letter and finish it with a period or other end punctuation. If bulleted list items are phrases or sentence fragments, begin each bulleted item with a lowercase letter. When bulleted items contain both phrases and sentences, various formats are possible, but the presentation should be consistent and logical.

Level 4 Headings Are Indented, Bolded, Written in Title Case, and End with a Period. Level 4 is a subheading of level 3, and the paragraph text starts on the same line. In active voice, the subject of a sentence is presented first, followed by the verb, and then the object of the verb. In passive voice, however, the object of the verb is presented first, followed by the verb, and then the subject. Both active and passive voices are permitted in APA style, but many writers overuse passive voice. Use the active voice as much as possible to create direct, clear, and concise sentences. When it is important to know who performed the action, use the active voice. When focus is on the object or recipient of the action rather than the actor, use the passive voice. However, your professor may specify which voice they prefer.

Level 5 Headings are Indented, Bolded, Italicized, Written in Title Case, and End with a Period. Level 5 is a subheading of level 4, and the paragraph text starts on the same line. Writers should use the singular "they" to refer to (a) a person who uses "they" as their pronoun, and (b) as a generic third-person singular pronoun to refer to a person whose gender is unknown or irrelevant to the context of the usage. The use of the singular "they" is inclusive of all people, helps writers avoid making assumptions about gender, and is part of APA style.




Appendix A

Appendices are used when supplementary information cannot or does not fit within the body of the paper, which can help the reader to avoid distraction while still receiving helpful information that may aid them in better understanding the content. According to Purdue Online Writing Lab (2019), appendices are "Primarily used to introduce research materials, specific details of a study, or participant demographics, appendices are generally concise and only incorporate relevant content. Much like with footnotes, appendices may require an acknowledgement of copyright and, if data is cited, an adherence to the privacy policies that protect participant identities."
