## Applicable Transfer Credit Hours

---

This transfer advising guide provides **58 college-level hours**, of which **57 will transfer and apply**, as **1 SCH of EDUC 1300** will transfer but will NOT be applicable towards the Texas A&M University - Central Texas baccalaureate degree in Nursing.

Note: Texas A&M University - Central Texas accepts a **maximum of 68 college-level hours** in transfer towards a baccalaureate degree. Students must complete the specified number of advanced credits and credits in residence for their degrees.

Note: Texas A&M University - Central Texas requires that all courses must be completed with a **grade of “C” or better** leading to a BSN degree.

Note: For the Alamo Colleges District this transfer advising guide is core complete but NOT degree complete and NOT field of study complete.

Central Texas Promise - Texas A&M University-Central Texas is committed to providing high quality and innovative educational opportunities at an affordable rate. Through our Central Texas Promise program, A&M-Central Texas guarantees eligible students will receive sufficient gift aid and non-loan financial assistance, from all sources, to cover the cost of mandatory tuition and fees. New degree-seeking undergraduate transfer students with an adjusted gross income of \$40,000 and a transfer GPA of 2.5 or higher are eligible when meeting enrollment requirements. ## Texas A&M University - Central Texas: Scholarship Information

---

### Transfer Merit Scholarship:

The A&M-Central Texas Transfer Merit Scholarship is a no-hassle, paperwork-free scholarship that rewards transfer students for strong academic performance. New undergraduate transfer students who qualify for in-state tuition (including non-residents with in-state waivers) and enroll in at least six semester credit hours may receive up to \$2,000 per year for up to three years, based on their cumulative transfer GPA. Students with a transfer GPA of 3.75 or higher may receive up to \$2,000 per year, and students with a transfer GPA of 3.50-3.74 may receive up to \$1,000 per year. Scholarship amounts are prorated based on enrollment, and recipients must maintain Satisfactory Academic Progress and meet residency and enrollment requirements. ### Phi Theta Kappa Scholarship:

Community college students who are members of Phi Theta Kappa (PTK) and transfer to A&M-Central Texas may also be eligible for the Phi Theta Kappa Scholarship. New transfer undergraduates who have completed an associate degree or at least 45 transferable hours, hold a minimum 3.5 transfer GPA, and enroll in at least 12 semester credit hours may receive \$500 per semester, up to \$1,000 per aid year, when all eligibility requirements are met. ## Texas Transfer Framework: Field of Study Curriculum (FOSC) Information

---

**Field of Study Curriculum (FOSC)** is a set of courses that fulfill lower-division (freshman and sophomore) requirements for a specific major/degree plan in addition to the core curriculum. FOSCs are guaranteed to transfer to any public college or university in Texas.

The Fields of Study are now part of **Texas Direct**. What is Texas Direct? Texas Direct is the state's effort to articulate seamless degree pathways between two- and four-year institutions.

Students who complete the Texas Core Curriculum and Field of Study at any public two-year institution automatically qualify to receive an associate degree - the Texas Direct Transfer Degree. They are also qualified to transfer their courses as a block applied directly to their selected major.

The Nursing FOS applies to the approved CIP Code (numerical codes corresponding to specific disciplines or subdisciplines) for the Revised Field of Study:

## Special Admissions for Nursing B.S.N at Texas A&M University - Central Texas

---

### Entry Requirements

#### General Education and Course Requirements

A&M-Central Texas is an upper-level university, therefore, the core curriculum/general education courses and non-nursing courses must be taken at another institution. Core curricula may also be accepted from other institutions.

#### Admissions Requirements

The Bachelor of Science degree in Nursing has additional entry requirements separate from general admission to the university. To be eligible to declare Nursing as a major and begin nursing courses, students must meet the below requirements:

### **Nursing Program Admission Requirements**

- Meet minimum university admission requirements
- Have a current unencumbered Texas Registered Nurse's (RN) license or of a Compact State\*
- Have earned a grade of "C" or higher in all courses leading to a BSN degree

\*Nursing students in their last year at a community college who 1). Meet general admission standards and 2). Have earned a grade of "C" or higher in all courses leading to a BSN degree may apply for conditional admission to the BSN program.

### **Application to the Nursing Program**

Nursing majors typically apply for admission to the Nursing program during the initial advising session prior to their first semester at A&M-Central Texas. The Nursing Department highly encourages Nursing majors to visit with their academic advisors to review program application timelines and requirements. Students must complete the below steps to apply for the Nursing Program.

- Gain admission to A&M-Central Texas
- Declare nursing as your major (completed during initial advising session)
- Submit online nursing program application

### **Conditional Admission Policy**

Nursing students conditionally admitted to the Nursing Program may enroll in the NURS 3300 and NURS 3317 courses. Upon successful completion of the Associate Degree in Nursing (ADN) and NCLEX examination, conditionally admitted students must provide proof of license to the Nursing Department to gain full program admission. Students unable to provide license or who do not pass the NCLEX exam will not be eligible to progress in the Nursing Program.

### **Progression Policy**

Nursing students are provided a Student Education Plan upon admission to guide program progression. Students may progress in the program when the following conditions are met:

- Successful completion of required nursing and non-nursing courses with a minimum grade of C. Students who earn below a grade of C on any two courses in the nursing program will not be eligible for progression.
- Transfer students from other programs must complete a minimum of 30 hours from A&M-Central Texas.
- Maintenance of an unencumbered license to practice as a Registered Nurse in the state of Texas (or Compact State) through the duration of the program.

### **Readmission Policy**

- Students who have an interruption—as defined as an inability to achieve a passing grade, withdrawal, or non-enrollment—must gain permission before taking any nursing course.
- The Division of Student Affairs, along with the Nursing Program Director, evaluates the student's request for readmission or to retake any nursing course.

- The student's general academic history, nursing course grades, and potential for success will be considered. Readmission or permission to retake any course is based on professional judgment and space availability.
  - Students who withdraw from a course or courses or receive a grade below a "C" should follow the procedure in the Progression Policy.
  - After lapse of one long semester, students wishing to return to the program
- A. Must notify the Nursing Program Director
  - B. Must submit a physician's clearance in order to return to classes if the absence was due to a health problem
  - C. Must meet with a nursing faculty member prior to registering to develop a degree completion plan
  - D. If the student has been out two long semesters or more, the student must also:
    1. Submit an updated Application to the Nursing Program
    2. Adhere to the most current catalog requirements
    3. Fulfill any requirements specified by the Nursing Program Director
    4. Complete the Nursing Program within five (5) calendar years from their initial enrollment

## Additional Texas A&M University - Central Texas Advising Notes

---

### Things to do and remember upon Admission to Texas A&M University - Central Texas

- Make an appointment with the academic advisor of the major, once accepted to Texas A&M University - Central Texas, in order to clarify department, college and university policies and procedures, to review course sequencing and to help with identifying resources for academic success. - Pay close attention to course sequencing and availability at Texas A&M University - Central Texas as it will affect the time it takes to complete the degree program.

### Transfer of Credit

Community college courses may not transfer into TAMUCT as upper-division courses (3000-4000 level), even though TAMUCT may have an upper-division course with exactly the same name and description. Community college courses may not be used to fulfill the upper-division requirement for graduation at TAMUCT. However, the course may be used as a substitute for an upper-division course with an approved substitution form signed by the chair and dean.

### Affordability

Texas A&M University-Central Texas is among the lowest cost public universities in the state and remains well below the state average for total charges. Students are not only able to take advantage of guaranteed tuition plans to help control the cost of their education, but A&M-Central Texas's Bachelor Bonus also caps tuition and mandatory fees at 12 semester credit hours. **Texas Education Code § 54.014** specifies that resident undergraduate students who initially enrolled fall 1999 and later may be subject to a higher tuition rate for attempting excessive hours at any public institution of higher education while classified as a resident student for tuition purposes.
