Course Description

Thesis research under the supervision of the committee chair. Credit given only upon acceptance of completed thesis. Prerequisites: 24 hours of graduate credit, including HIST 598 and at least one research seminar. Approval of graduate program leader in consultation with committee chair.

Objectives

1. Employ sound research methods contributing to the scholarship in the student's area of specialization and thesis topic in the production of a research proposal and subsequent thesis
2. In the narrative for the thesis, demonstrate effective academic writing following the discipline norms for history as illustrated in Strunk and White, *Elements of Style*. Produce a thesis that conforms to the guidelines in the TAMUCT Thesis Manual, available at <http://www.ct.tamus.edu/departments/graduatestudies/formsgraduatestudies.php>
3. In the first chapter of the thesis, synthesize and evaluate the literature relating to the thesis topic and explain the original contribution the thesis will make to the literature on that topic.
4. In all citations and the bibliography, utilize correct documentation of sources following the Chicago Style as summarized by Kate Turabian.
5. In individual chapters of the thesis and the conclusion, explain and support all conclusions based on sound logic and historical evidence.
6. Appraise the validity and context of all sources used to support the narrative or conclusions of the thesis.
7. Produce a thesis that represents original scholarship that is publishable or that can be further developed into publishable work.

Required Texts

Kate Turabian, *A Manual for Writers of Research Papers, Theses, and Dissertations*, 7th Ed., Chicago, University of Chicago Press, 2007.

William Strunk and E.B. White, *The Elements of Style*, 3rd Ed., New York: MacMillan Publishing Co., 1979. New editions of Strunk and White are also acceptable.

Evaluation

A grade of “I” is assigned until a completed thesis is accepted by the thesis committee and the AVP for Graduate Studies and Research. Upon successful completion a grade of “P” is assigned. I am available by appointment. You be in weekly contact with me, and schedule meetings as needed.

Drop Policy.

If you discover that you need to drop this class, you must complete a [Drop Request Form](https://www.tamuct.edu/registrar/docs/Drop_Request_Form.pdf) [https://www.tamuct.edu/registrar/docs/Drop_Request_Form.pdf].

Professors cannot drop students; this is always the responsibility of the student. The Registrar's Office will provide a deadline on the University Calendar for which the form must be completed, signed and returned. The University Writing Center.

Located in 416 Warrior Hall, the University Writing Center (UWC) at Texas A&M University-Central Texas is a free workspace open to all TAMUCT students from 10am-5pm Monday-Thursday with satellite hours in the University Library on Mondays from 6:00-9:00pm. Students may arrange a one-on-one session with a trained and experienced writing tutor by visiting the UWC during normal operating hours (both half-hour and hour sessions are available) or by

making an appointment via [WOnline](https://tamuct.mywconline.com/) [https://tamuct.mywconline.com/]. In addition, you can email Dr. Bruce Bowles Jr. at bruce.bowles@tamuct.edu to schedule an online tutoring session. Tutors are prepared to help writers of all levels and abilities at any stage of the writing process. While tutors will not write, edit, or grade papers, they will assist students in developing more effective composing practices. By providing a practice audience for students' ideas and writing, our tutors highlight the ways in which they read and interpret students' texts, offering guidance and support throughout the various stages of the writing process. In addition, students may work independently in the UWC by checking out a laptop that runs the Microsoft Office suite and connects to WIFI, or by consulting our resources on writing, including all of the relevant style guides. Whether you need help brainstorming ideas, organizing an essay, proofreading, understanding proper citation practices, or just want a quiet place to work, the University Writing Center is here to help!

University Library.

The University Library provides many services in support of research across campus and at a distance. We offer over 200 electronic databases containing approximately 250,000 eBooks and 82,000 journals, in addition to the 72,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On-campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available twenty-four hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place on Skype or in-person at the library. Assistance may cover many topics, including how to find articles in peer-reviewed journals, how to cite resources, and how to piece together research for written assignments.

Our 27,000-square-foot facility on the A&M-Central Texas main campus includes student lounges, private study rooms, group work spaces, computer labs, family areas suitable for all ages, and many other features. Services such as interlibrary loan, TexShare, binding, and laminating are available. The library frequently offers workshops, tours, readings, and other events.
