## **COURSE INFORMATION**

### **Course Overview and description:**

Studies the issues of Network and Systems Security as a continuous process involving analysis, implementation, evaluation and maintenance. Topics will include addressing computer-related risks, case analysis, and future trends. The course will provide approaches, techniques, and best practices for securing modern electronic data systems and networks. Areas covered include information and message security, database and file integrity, physical security, security management, security risk analysis, and encryption/cryptography. Will include practical laboratories in the analysis, and configuration of networking security protocols and tools.

Prerequisites: ITNW 2321 or CIS 3347 or approval of Department Chair.

### **Course Objective:**

#### **Student Learning Outcomes:**

Students taking this course will be able to understand the common threats of computing resources, how to detect and prevent those threats in today's computing systems, what are the techniques hackers used to compromise security, how to encrypt message while sending over the communication network.

#### *Exams*

There will be one midterm and one final exam. The midterm exam will contain 200 points, and the final exam will contain 200 points. The final exam will not be comprehensive for this course. Both exams will be conducted in class.

**Five** assignments (homework and lab assignments) will be given to the students. The due dates of these assignments will be posted in canvas. Each assignment will be worth **60** points.

### *Class Participation*

Attending the class lectures is mandatory for this course. Class attendance will be counted toward class participation marks. Total class participation is worth **60** points.

### **University Library.**

The University Library provides many services in support of research across campus and at a distance. We offer over 200 electronic databases containing approximately 250,000 eBooks and 82,000 journals, in addition to the 85,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place on Skype or in-person at the library.
