COURSE INFORMATION

Course Overview and description: This course examines the history of education in the United States through a study of the philosophical, historical, psychological and social foundations of curriculum. Emphasis is on the development of a philosophy of education and critical thinking about issues in education. Students must complete this course within the first twelve semester hour of graduate study.

Course Objective: The goal of this course is to deepen your conceptual understanding of the underlying mathematics within the elementary school curriculum. During the semester you will be introduced to and immerse yourself in learning mathematics through the problem solving approach. In addition you will engage in the pedagogy pertaining to the learned mathematics. The mathematics in the course emphasizes topics relevant to teaching children from prekindergarten to grade 8 according to the TEKS.

Student Learning Outcomes:

1. Explain the historical, philosophical psychological and cultural factors that have contributed to the evolution of curriculum in the United States.
2. Analyze and evaluate the significance of various philosophies in the formulation of curriculum.
3. Examine theoretical foundations of education and articulate a philosophy of education.
4. Synthesize research on current issues in education.
5. Analyze journal articles on current and past educational trends

Drop Policy.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place on Skype or in-person at the library. Assistance may cover many topics, including how to find articles in peer-reviewed journals, how to cite resources, and how to piece together research for written assignments.

Our 27,000-square-foot facility on the A&M-Central Texas main campus includes student lounges, private study rooms, group work spaces, computer labs, family areas suitable for all ages, and many other features. Services such as interlibrary loan, TexShare, binding, and laminating are available. The library frequently offers workshops, tours, readings, and other events.
