**COURSE INFORMATION**

Course Overview and description: Theory and instructional strategies for teaching the writing process in elementary and middle schools. Includes stages of the writing process, issues at the different grade levels, teaching with mini-lessons, early literacy, spelling, handwriting, developing listening skills, STAAR writing, and the use of children’s literature to teach writing.

**COURSE REQUIREMENTS**

**Persuasive Essay: (10 points)**

You will choose a topic related to education and compose a written piece in which you attempt to persuade others to see your argument or point of view. This will be a new and original piece written specifically for this class, and it may not be used in another class. This piece will be taken through the writing process from collecting ideas to published final version. All prewriting, first drafts with revisions and peer conference notes, and/or teacher conference notes must be turned in along with the final copy for full credit on this assignment. The final copy must be word processed, and it should reflect changes made from revisions and editing. A grading rubric will be provided and details will be discussed in class.

**Expository Essay: (10 points)**

From a list of expository prompts, you will choose a prompt to respond to. This will be a new and original piece written specifically for this class, and it may not be used in another class. This piece will be taken through the writing process from collecting ideas to published final version. All prewriting, first drafts with revisions and peer conference notes, and/or teacher conference notes must be turned in along with the final copy for full credit on this assignment. The final copy must be word processed, and it should reflect changes made from revisions and editing. A grading rubric will be provided and details will be discussed in class.

**Handwriting: (10 points)**

You will demonstrate mastery of form through ‘consistent application’ of manuscript and cursive script in model lessons, writing samples and hand-written work. Evaluation: On-going observations of writing in assignments and working with students, and/or a handwriting assessment.

**Chapter Quizzes:** (points vary, 10%) Chapter quizzes will be given periodically, both announced and unannounced. They will be given at the beginning of class and no make-ups will be provided. Points will vary on each quiz. The lowest grade received out of all quizzes will be dropped.

**Capstone Project (50 points)**

This assignment will consist of a collection of implemented writing lesson plans, reflections, and instructor observations. A packet with specific expectations and rubric will be provided.

**Final Exam** (50 points, 10%) The final exam will be comprehensive and given at the end of the semester.

On-campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available twenty-four hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place on Skype or in-person at the library. Assistance may cover many topics, including how to find articles in peer-reviewed journals, how to cite resources, and how to piece together research for written assignments.

Our 27,000-square-foot facility on the A&M-Central Texas main campus includes student lounges, private study rooms, group work spaces, computer labs, family areas suitable for all ages, and many other features. Services such as interlibrary loan, TexShare, binding, and laminating are available. The library frequently offers workshops, tours, readings, and other events. ##### **A Note about Sexual Violence at A&M-Central Texas**

#### **INSTRUCTOR POLICIES.**

**Field Experience:** Students of Texas A&M University-Central Texas working toward becoming teachers are guests in the schools in which they are placed. When you are at a local school, you will wear a polo shirt or buttoned-down shirt with the university logo (these shirts are available for purchase at the university bookstore or other suppliers) and slacks or skirts with reasonable length. In addition, you will remove facial and/or multiple ear piercings. You will be clean and follow the rules of good hygiene. If you are tardy or not dressed professionally, you will be allowed to participate in the field experience and sent home. Missed field experiences will not be made up.

**Late Work:** Work is due according to the course calendar. When hard copies are specified, they

are due at the beginning of class. No late work will be accepted except under extenuating circumstances which are communicated with the professor in a timely manner. If extension is granted, the late work may be subject to deduction of points of 10% each day past the original due date.

**Attendance:** Professional behavior and commitment to teaching are the expectations. Attendance and punctuality are required. It is not possible to make up the work missed due to late arrival or early departure since the class period involves interactions of students, instructor, and content. **Two class absences** for any reason will result in lowering the final grade by a letter grade. **Three or more absences** will result in failure of the class. All tardies or early departures will result in the loss of professionalism points. **Two tardies or early departures** will count as one absence. Students missing class are responsible for notes, handouts, assignments, and any changes in schedules. Student missing capstone field experience classes will have that portion of the points deducted from their capstone grade.

**Class Participation:** Being prepared to participate includes completing assigned reading and bringing necessary textbooks, assignments, and materials to class. You are expected to read before the class session, actively participate in classroom assignments and discussions, and fully participate in online work. Any in-class presentations and activities cannot be made up. The use of technology, which include cell phones and other electronic devices, can enhance learning and the educational experiences; however, it can also become a distraction to the learning tasks at hand. Off-task technology usage is both unprofessional and disrespectful to everyone involved.
