COURSE INFORMATION

Course Overview and description:

This course examines the history of education in the United States through a study of the philosophical, historical, psychological and social foundations of curriculum. Emphasis is on the development of a philosophy of education and critical thinking about issues in education. Students must complete this course within the first twelve semester hour of graduate study.

Course Objective:

The goal of this course is to deepen your conceptual understanding of the underlying foundations and history of education in the United States. During the semester you will be introduced to various aspects of education including: teaching, philosophical aspects, the essence of education, and various other aspects.

Student Learning Outcomes:

1. Explain the historical, philosophical psychological and cultural factors that have contributed to the evolution of curriculum in the United States.
2. Analyze and evaluate the significance of various philosophies in the formulation of curriculum.
3. Examine theoretical foundations of education and articulate a philosophy of education.
4. Synthesize research on current issues in education.
5. Analyze journal articles on current and past educational trends.

Educational Philosophies Presentations. (20 Pts.). Student research and present information about well-known educators and their philosophies. Outcomes 1, 2, and 3.

2 Article Analyses. (20 Pts). Students will present their articles in class. As they present their article will be brought up on a screen so other students may view the article while it is being presented. This gives students 36 journal articles to evaluate. Outcomes 4 and 5.

Chapter Discussions (30 Pts.). The chapters of our text, *Foundations of American education: Becoming effective teachers in challenging times* will be assigned to groups. Each group will create discussion questions based on their assigned chapters. Every member of each group will be expected to create questions for their chapters. Three groups will present 3 chapters and two groups will present 2 chapters. Outcomes 1-5.

Midterm Exam. (10 Pts.). The midterm exam will be take home or in class. Outcome 3.

Final Exam (10 Pts.). The final exam will be take home or in class. Outcomes 1-5.

University Library.

The University Library provides many services in support of research across campus and at a distance.
