COURSE INFORMATION

Catalog Course Description

Study selected problems in business, and become acquainted with current research being conducted within the specific area of interest. Participate in directed reading of sources selected in concert by the student and professor. Engage in independent research, reading and discussions under the personal direction of the instructor. Topics may vary according to student need.

Prerequisite(s): Permission of department chair.

Course Level Objective

The student will analyze the legal impacts on Businesses through a series of short papers over recent governmental actions.

Required Reading and Textbook(s):

There is no required text for this course. You will rely on electronic sources for your work via the internet or library databases.

Course Requirements

Impact Papers (**2 @ 100 points each**) – Over the last year, a lot has happened in the courts, Congress, and the Presidency that has had, or will likely have, profound impacts on business for years to come. In consultation with me, you'll select two of these major events to write an approximately six-page paper on (exclusive of title page and references). As we decide on a topic, we will discuss the basic parameters to be explored and analyzed. 80% of the score will be based on the substantive content and 20% will be based on grammatical accuracy, as well as proper citations. These papers will be submitted in Canvas with Veri-cite checking your work. The Veri-cite score probably should not exceed 10%. **Your first paper will be due on Saturday, June 30th, and your second will be due on Thursday, July 26th. If your paper is late, you will lose 10 points per day late.**

Grading Scale

Note the C, D, and F Ranges Especially

180-200 = A - Good

160-179 = B - Acceptable

140-159 = C – Needs Improvement – Remember you need a 3.0 to graduate, so a C hurts!

139 or less = F – Unacceptable

Drop Policy.

University Library.

The University Library provides many services in support of research across campus and at a distance. We offer over 200 electronic databases containing approximately 250,000 eBooks and 82,000 journals, in addition to the 85,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place on Skype or in-person at the library. Assistance may cover many topics, including how to find articles in peer-reviewed journals, how to cite resources, and how to piece together research for written assignments.

Our 27,000-square-foot facility on the A&M-Central Texas main campus includes student lounges, private study rooms, group work spaces, computer labs, family areas suitable for all ages, and many other features.
