COURSE INFORMATION

Course Overview and catalog description:

This course is designed to develop the capacity of preservice educators to plan, organize, deliver, and evaluate instruction for diverse learners through the effective use and integration of current technologies. The use of technology for ethical and professional communication with colleagues, community, and students is also addressed.

Course Pre-requisites

Admission to Clinical Teaching; successful completion of designated content area Texas Examination of Educator Standards (TExES); concurrent enrollment in EDUC 4391 and EDUC 4335, or approval of Curriculum & Instruction Program.

Course Objective:

After completing this coursework, the student will be a reflective, professional educator who makes effective educational decisions that support the creation of dynamic learning environments. The student will demonstrate effective practices in a field-based setting and reflect on his/her role as a professional educator as he/she moves forward on the continuum from pre-service to in-service educator-related information, regardless of his/her location.

Upon completion of this course, learners will be able to:

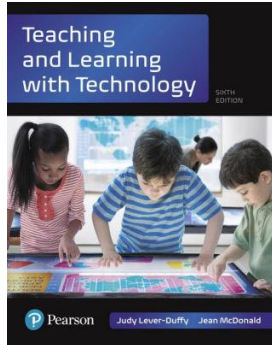
1. Identify, describe, and apply emerging technologies in teaching and learning environments

3. Plan, design, and assess effective learning environments and experiences

5. Develop technology-enabled assessment and evaluation strategies
6. Compare and contrast social, ethical, and legal issues surrounding technology
7. Facilitate instruction in the new literacies that emerge within digital / interactive learning environments

COURSE REQUIREMENTS

Discussion boards (15 pts.)

For every discussion board listed on the syllabus you have to post to the discussion board at least once. Your post can be a comment, a meaningful question that can lead to a discussion among the students, a reaction to a comment, an answer to a question, etc. The purpose of the discussion board is to make you think about the articles/videos and then get engaged in a meaningful discussion with your classmates. Simply waiting until the last minute and posting some comment without reading the other postings will not get full credit. Also, to make sure you address any question or comment posted as a reply to your post in a specific discussion board, make sure you check an assigned discussion board before it shuts down. In other words, you are not done with a discussion board just by posting to it.

There will be 7 discussion boards throughout this semester. For these discussion boards, I will assign you articles to read, video clips to watch, certain activities to do, etc. I will leave every discussion board open for 4 days, after which it will not be available. Please make sure you will not miss the deadlines for the discussion boards. **After the deadline, I will not open a discussion board.** The discussion boards will be open every week from Saturday 8:00 am, to Tuesday 11:55p.m.

Digital portfolio (15 pts.)

Using Google Sites every student will create his/her digital portfolio. Your digital portfolio is where you compile some of the content you create during this semester. You need to start working on this assignment right from the beginning of the semester.

Your digital portfolio must contain AT LEAST the following pages:

1. About me (include your resume on this page)
2. Teaching philosophy
3. Teaching methodology related to your own specialty (language arts, math, science, etc.)
4. Technology integration: Any technology assignment/project you have completed and are proud of

Chapter Projects (40 pts.)

These are projects that you need to complete every time we are done with a chapter in your textbook. Detailed information on these projects can be found at the end of every chapter. Specific requirements may also be posted to Canvas if necessary.

Group Project (10 pts.)

This is a group project for which you will either be assigned to a group or choose your own group. You can find the project details on Canvas.

Quizzes (20 pts.)

We will have multiple quizzes along the way. Please make sure you read the assigned chapters/materials before a quiz becomes available online.

Drop Policy.

Professors cannot drop students; this is always the responsibility of the student. University Writing Center.

Located in Warrior Hall 416, the University Writing Center (UWC) at Texas A&M University–Central Texas (TAMUCT) is a free workspace open to all TAMUCT students from 10:00 a.m.-5:00 p.m. Monday thru Thursday with satellite hours in the University Library Monday thru Thursday from 6:00-9:00 p.m. This semester, the UWC is also offering online only hours from 12:00-3:00 p.m. on Saturdays.

Tutors are prepared to help writers of all levels and abilities at any stage of the writing process. While tutors will not write, edit, or grade papers, they will assist students in developing more effective composing practices. By providing a practice audience for students' ideas and writing, our tutors highlight the ways in which they read and interpret students' texts, offering guidance and support throughout the various stages of the writing process. In addition, students may work independently in the UWC by checking out a laptop that runs the Microsoft Office suite and connects to WIFI, or by consulting our resources on writing, including all of the relevant style guides. Whether you need help brainstorming ideas, organizing an essay, proofreading, understanding proper citation practices, or just want a quiet place to work, the UWC is here to help!

Students may arrange a one-on-one session with a trained and experienced writing tutor by visiting the UWC during normal operating hours (both half-hour and hour sessions are available) or by making an appointment via [WCOOnline](#). University Library.

The University Library provides many services in support of research across campus and at a distance. We offer over 200 electronic databases containing approximately 250,000 eBooks and 82,000 journals, in addition to the 85,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place on Skype or in-person at the library. Assistance may cover many topics, including how to find articles in peer-reviewed journals, how to cite resources, and how to piece together research for written assignments.

Our 27,000-square-foot facility on the A&M-Central Texas main campus includes student lounges, private study rooms, group work spaces, computer labs, family areas suitable for all ages, and many other features. Services such as interlibrary loan, TexShare, binding, and laminating are available. The library frequently offers workshops, tours, readings, and other events.
