Course Objective:

This course provides an overview of the principles of program design. Methods of resistance training and assessment are emphasized in laboratory demonstrations. . PRER: EPHP 3302:

Student Learning Outcomes:

1. Demonstrate an understanding of muscle physiology, neural anatomy, bone and connective tissue and their adaptations to strength training.
2. Describe the biomechanics of strength training and how it applies to program design.
3. Discuss various training principles and corresponding techniques
4. Develop an appropriate program utilizing a design based on a theoretical athlete and their respective sport.
5. Identify appropriate facility layouts and policies and risk management procedures

COURSE REQUIREMENTS

Course Requirements: (100 total points)

1. **Module quizzes** (50 points; 5 quizzes x 10 points each) – This course utilizes a flipped design, and students are expected to come to class with a grasp of the information to be discussed. Students will complete quizzes during weeks 2-6 PRIOR TO CLASS over the chapters assigned. *Quizzes are due on Tuesdays at 8AM.*
2. **Comprehensive final exam** (30 points) - Students will demonstrate a grasp of the principles of the course through a final exam on the last class date. The final will take place in room 207 of Founder's Hall.
3. **Teaching demonstration** (20 points) – Students will be placed into groups and assigned a chapter to instruct a mock teaching/training session with other students. Grades will be determined by grasp of the content presented (10 points) and ability to instruct/communicate the principles (10 points). Demonstrations should last 20-25 minutes each. Groups will upload an outline of their session by 10/6 at 11:59PM.

The University Library provides many services in support of research across campus and at a distance. We offer over 200 electronic databases containing approximately 250,000 eBooks and 82,000 journals, in addition to the 85,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place on Skype or in-person at the library. Assistance may cover many topics, including how to find articles in peer-reviewed journals, how to cite resources, and how to piece together research for written assignments.

Our 27,000-square-foot facility on the A&M-Central Texas main campus includes student lounges, private study rooms, group work spaces, computer labs, family areas suitable for all ages, and many other features.
