COURSE INFORMATION

Course Overview and description: This course is an examination of social, political, ethical, and economic issues that impact higher education.

Student Learning Outcomes:

1. Identify current and emerging social, political, and economic issues in higher education
2. Identify potential ethical issues and dilemmas in higher education
3. Analyze the immediate and long-term implications of current and emerging trends

Required Reading and Textbook(s):

COURSE REQUIREMENTS

Course Requirements:

1. Annotated Bibliography (10 points)- Students will submit an annotated bibliography of the articles in the course e-reserve. Students should focus on developing concise summarizations that overview the article purpose, findings/recommendations, and general methods of inquiry. APA formatting is required. A rubric is provided in Canvas.
2. Leadership Interview (20 points)- Students will conduct one 45 to 90-minute recorded interview with an approved individual currently employed at an institution of higher education and submit a reflective essay of at least five pages. It is suggested that the individual hold the title of Director, Chair, or higher. Interview questions should emphasize the individual's leadership philosophy, the specific questions included below, and questions of professional interest to the student. Students should submit digital recordings of the interviews for verification purposes. A rubric is provided in Canvas.
 - *What do you see as one of the most dramatic challenges higher education administrators are currently facing?*
 - *What do you see as an impending challenge that administrators will encounter in the next five years?*
 - *What is your philosophy on ethics and leadership during times of change?*
 - *As a leader, how do you develop/gain the foresight necessary to identify a trend and proactively change?*
3. Chronicle Article Critical Review 1 (20 points)- Students will select a relatively recent (i.e., last four months) article from the Chronicle of Higher Education that discusses a trend or issue related to government, legal, or financial matters and submit a critical review of at least 2 pages. APA formatting is required. A rubric is provided in Canvas.
4. Chronicle Article Critical Review 2 (20 points)- Students will select a relatively recent (i.e., last four months) article from the Chronicle of Higher Education that discusses a trend or issue related to student access & success, diversity, assessment, or technology focused and submit a critical review of at least 2 pages. APA formatting is required. A rubric is provided in Canvas.
5. Final exam (30 points)- Students will demonstrate their grasp of course content through an online final exam.

Drop Policy.

If you discover that you need to drop this class, you must complete a [Drop Request Form](https://www.tamuct.edu/registrar/docs/Drop_Request_Form.pdf) [https://www.tamuct.edu/registrar/docs/Drop_Request_Form.pdf].

Professors cannot drop students; this is always the responsibility of the student. The Registrar's Office will provide a deadline on the Academic Calendar for which the form must be completed, signed and returned. University Writing Center.

Located in Warrior Hall 416, the University Writing Center (UWC) at Texas A&M University–Central Texas (TAMUCT) is a free workspace open to all TAMUCT students from 10:00 a.m.-5:00 p.m. Monday thru Thursday with satellite hours in the University Library Monday thru Thursday from 6:00-9:00 p.m. This semester, the UWC is also offering online only hours from 12:00-3:00 p.m. on Saturdays.

Tutors are prepared to help writers of all levels and abilities at any stage of the writing process. While tutors will not write, edit, or grade papers, they will assist students in developing more effective composing practices. By providing a practice audience for students' ideas and writing, our tutors highlight the ways in which they read and interpret students' texts, offering guidance and support throughout the various stages of the writing process. In addition, students may work independently in the UWC by checking out a laptop that runs the Microsoft Office suite and connects to WIFI, or by consulting our resources on writing, including all of the relevant style guides. Whether you need help brainstorming ideas, organizing an essay, proofreading, understanding proper citation practices, or just want a quiet place to work, the UWC is here to help!

Students may arrange a one-on-one session with a trained and experienced writing tutor by visiting the UWC during normal operating hours (both half-hour and hour sessions are available) or by making an appointment via [WOnline](#). University Library.

The University Library provides many services in support of research across campus and at a distance. We offer over 200 electronic databases containing approximately 250,000 eBooks and 82,000 journals, in addition to the 85,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place on Skype or in-person at the library. Assistance may cover many topics, including how to find articles in peer-reviewed journals, how to cite resources, and how to piece together research for written assignments.

Our 27,000-square-foot facility on the A&M-Central Texas main campus includes student lounges, private study rooms, group work spaces, computer labs, family areas suitable for all ages, and many other features. Services such as interlibrary loan, TexShare, binding, and laminating are available. The library frequently offers workshops, tours, readings, and other events.
