## Course Description

An in depth study of representative types of Shakespeare's drama and poetry. Credit for both ENGL 400 and THEA 400 will not be awarded. Prerequisites: ENGL 111, 112, and 6 hours sophomore ENGL.

## Course Objectives and Learning Outcomes

By the end of this course, you should be able to:

- Read and comprehend Shakespeare's works in the original Early Modern English.
- Complete close readings of Shakespeare's works in addition to analyzing his writing through biographical, historical, linguistic, and social contexts.
- Formulate and express both written and spoken analyses effectively.
- Understand how adaptation of Shakespeare's materials necessitates interpretation of them, and produce a short Shakespeare adaptation accompanied by a reflection on how your adaptation provides an interpretation of the original text.
- Conduct primary and secondary research on a research topic related to one or more of the semester's assigned readings.
- Produce an analytical research essay on a research topic related to one or more of the semester's assigned readings.

## Required Textbooks

Please note that these specific editions of the assigned texts are the recommended ones. Because editions of plays may vary significantly based on source texts consulted and other editorial decisions, it is important that we all work from the same edition in class. **If you use an edition other than the recommended one, it is essential that your edition contain line numbers. Line numbers are necessary for correct in-text citation of plays, as you must be able to identify quotations by act, scene, and line(s).**

## Participation

Participation is based on course attendance and involvement in class discussions and activities. You will receive a participation score (rated 0-10, with 10 representing excellent participation and 0 representing no participation) at the end of each week, and the average of weekly participation scores will determine the final participation score. A participation rubric will be distributed during Week 1. See the Attendance Policy for information regarding the participation score and absences.

## Short Written Reflections

You will complete a total of ten short written reflections between Weeks 2 and 12 of the semester. Reflections are due at 11:59 PM on the Thursday of each week they are assigned. You will receive a prompt with more information regarding weekly reflections during Week 1.

## Creative Interpretation

The Creative Interpretation assignment provides an opportunity for you to think about adaptation and interpretation as elements which go hand-in-hand. For this assignment, you will produce a short adaptation of a scene in one of the plays we read this semester. This adaptation is to be accompanied by a 500-word reflection on how your adaptation provides a specific interpretation of the scene you adapt. A prompt and rubric detailing the assignment will be distributed at the beginning of the semester. The final draft of the Creative Interpretation will be uploaded to a plagiarism detection service via the link provided on the course Canvas page.

## Essay Exams

The two “take-home” essay exams will be distributed at midterm and the end of the semester one week in advance of the due date. The exams will consist of several prompts, of which two must be selected and answered. These exams will be open book and open note, but are not to be completed in collaboration with others. A rubric detailing how essays will be scored will be distributed prior to exam days. The final drafts of both essay exams will be uploaded to a plagiarism detection service via the link provided on the course Canvas page.

## Scholarship Review

The Scholarship Review essay will be 5-7 pages long and will involve locating, summarizing, assessing, and situating in a scholarly conversation two peer-reviewed articles on a single play assigned this semester. A prompt and rubric for this essay will be distributed at the start of the semester. The final draft of the essay will be uploaded to a plagiarism detection service via the link provided on the course Canvas page.

## Instructor Availability

You are welcome to contact me with questions or comments via email (but please send emails to me via the Canvas messaging system only, unless the site is down). I endeavor to answer all emails within 24 hours of receiving them, not counting weekends and holidays. Appointments are not required during regularly-held office hours (see top of syllabus for details); you can stop by at any time during office hours. You may request an appointment outside normal office hours in person or by email; however, I do ask that any appointment request be made *at least* 24 hours in advance of the desired meeting time. Do not assume that the meeting will take

place unless I have responded to your request and confirmed the time. **Please only request an appointment if it is impossible for you to meet during regularly-scheduled office hours.**

## Draft Review Policy

Students often ask me whether I'll look at major assignment drafts and give advice on how to improve them. The answer is yes, with two requirements. First, students who wish for me to review an entire draft must come to office hours or make an appointment to do so and must bring a print copy of the draft with them. I will not review drafts that are emailed to me with no explanation; over email, I will only address specific questions that can be answered in a brief email response. Second, students who wish for me to review an entire draft must also come to the meeting with two or three specific areas in their assignment that they'd like to discuss. You might mention paragraph organization/structure, thesis statement strength, or other such topics. This does not mean that I will not comment on other areas for improvement; I have found that beginning by discussing specific aspects of the project identified by the student helps to make the meeting time more effective and focused.

## Classroom Etiquette

Students are to maintain a high level of collegiality and respect when interacting with one another and the instructor. Disagreements are a normal and often productive aspect of academic discourse, and differences in viewpoint relevant to the class meeting may be expressed and explored during discussion portions of the class. However, participants engaged in any variety of classroom discussion must remain respectful to all parties involved and focused on a topic relevant to the class meeting. Students who do not abide by these requirements (either through showing disrespect to others or through refusing to remain on-topic) will be asked to leave the classroom.

## Late Submission Policy

I do not accept late/make-up work for assignments unless the student has missed the deadline due to a university-excused absence or emergency (for example, an illness or injury experienced by the student or a member of his or her immediate family).

If you miss a deadline due to a university-approved reason, it is your responsibility to initiate a discussion regarding a deadline extension in a timely manner, ideally within 24 hours of missing the deadline. After a new deadline for the assignment is established and the confirmation of the new deadline is emailed to you, you must abide by this deadline or else receive a zero on the assignment. *In all situations regarding missed and/or extended deadlines, it is the student's responsibility to contact the instructor if any issues arise. If I do not hear from you and do not*

*have your submission after a deadline passes, I will assume that you do not intend to turn in the assignment and will put a zero in the gradebook.*

## Attendance Policy

Because class meetings this semester will be light on lecture and heavy on activity and discussion, attendance is of utmost importance. You may miss up to two classes without a university-excused reason (such as an illness or medical emergency experienced by yourself or a member of your immediate family) before your participation score will be affected. Any unexcused absences beyond these two will result in a zero participation score for the missed day, which will be factored into the participation score at the end of the week. **Any in-class activities or assessments (including exams) missed without a university-excused reason cannot be made up, even if they are missed during the two allotted “free” absences.** A sign-in sheet will be passed around during each class meeting; it is your responsibility to initial the sheet to record your attendance each meeting.

Be aware that I do consider classes missed in order to care for an ill member of your immediate family to be excused. This includes absences necessitated when a child cannot attend school or daycare due to an illness. I do ask that you contact me as soon as possible in order to let me know that you will miss class due to an excused absence (of any variety) so that I can mark your attendance record accordingly and so that we can discuss any relevant make-up assignments or extensions. It is best that you let me know (either in person or via email) about upcoming absences as early as possible, or within 24 hours of the missed class if you are unable to let me know in advance.

## Drop Policy

Professors cannot drop students; this is always the responsibility of the student. The Registrar's Office will provide a deadline on the Academic Calendar for which the form must be completed,

signed and returned. Once you return the signed form to the Registrar's Office, you must go into Warrior Web and confirm that you are no longer enrolled. If you still show as enrolled, FOLLOW-UP with the Registrar's Office immediately. You are to attend class until the procedure is complete to avoid penalty for absence.
