Course Overview and description:

The purpose of this course is to help students understand contemporary issues in American policy. Several ideas will be addressed including: federalism; the role of government; limitations

on government resources; varying viewpoints on each of the policy issues addressed.

Student Learning Outcomes:

By the end of the course, students should be able to: 1. Describe the policy process and identify general difficulties. 2. Discuss factual elements about a wide array of policy issues. 3. Articulate opposing positions on several issues. 4. Cite major developments related to major issues. 5. Critically analyze arguments for and against certain policies and the impact policy changes may have

Grading Criteria Rubric and Conversion

Discussion boards will open once a week on Canvas. They will require responses to particular questions related to readings or current events. Comments must be meaningful, useful, and most importantly, respectful. Expectations for the paper are provided below. There will also be two (2) opinion papers which will replace that weeks discussion boards. These one-page commentaries will be a more in depth discussion board with you responding to a question about current events or topic from the book. The attendance score will be reduced by 1 percentage point for each unexcused absence. Exams will contain a mixture of question types such as short answer and multiple choice questions, the final exam is cumulative.

- **Research Paper: 20%.**

- **5%: Bibliography**
- **5%: Grammar and Formatting**
- **10% Content**

Each student will be responsible for completing one research paper of **5-7 pages**. Formatting guidelines are as follows: double-spaced lines, one-inch margins (i.e., top, bottom, left, and right), and Times New Roman font. A bibliography must be included and follow American Political Science Association Style for citations. Papers will be graded based on grammar, content, and clarity.

Topics must be approved by **Feb 21** and an annotated bibliography will be due on **Mar 21**. The final paper is due **Apr 11**.

Please submit topics **in writing** either in class or by email. Make sure that I respond with approval before continuing with your work. The annotated bibliography will be submitted **on Canvas by 5pm Mar 21**. **Papers must be submitted in hard copy by the start of class on Apr 11**. Any papers turned in after this time will be considered late. Each day late will result in the loss a full letter grade.

Posting of Grades

Grades will be posted on Canvas within a couple of days of each assignment.

Drop Policy.

If you discover that you need to drop this class, you must complete a [Drop Request Form](https://www.tamuct.edu/registrar/docs/Drop_Request_Form.pdf) [https://www.tamuct.edu/registrar/docs/Drop_Request_Form.pdf].

Professors cannot drop students; this is always the responsibility of the student. The Registrar’s Office will provide a deadline on the Academic Calendar for which the form must be completed, signed and returned. University Library.

The University Library provides many services in support of research across campus and at a distance. We offer over 200 electronic databases containing approximately 250,000 eBooks and 82,000 journals, in addition to the 85,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled

for more comprehensive assistance, and may take place on Skype or in-person at the library. Assistance may cover many topics, including how to find articles in peer-reviewed journals, how to cite resources, and how to piece together research for written assignments.

Our 27,000-square-foot facility on the A&M-Central Texas main campus includes student lounges, private study rooms, group work spaces, computer labs, family areas suitable for all ages, and many other features. Services such as interlibrary loan, TexShare, binding, and laminating are available. The library frequently offers workshops, tours, readings, and other events.
