COURSE INFORMATION

Course Overview and description:

To describe basic principles of behavior so that the students learn how environmental events influence human behavior. They will also learn to describe behavior modification procedures so that the student learns the strategies by which human behavior may be changed.

Course Objective:

To introduce students to the terms, procedures, and principles that influence behaviors.

Student Learning Outcomes:

SLO1: Student will understand the information presented on behavior recording, graphing, and measuring change.

SLO2: Students will understand the basic principles of operant and respondent behaviors.

SLO3: Students will be able to differentiate between procedures used to establish new behaviors, increase desirable behaviors, and decrease undesirable behaviors.

SLO4: Students will learn to see how the principles of behavior are applied in everyday situations, across all people, settings, and opportunities.

SLO5: Students will learn about professional practice, certification, and ethics as governed Behavior Analyst Certification Board (BACB).

Required Reading and Textbook(s):

Miltenberger, Raymond. Behavior Modification: Principles and Procedures. 6th edition. Printed by Cengage Learning.

The 5th edition is fine but be aware that the chapters may not line up with the 6th edition.

COURSE REQUIREMENTS

Chapter Quizzes 20pts each= 140 points total

Quizzes cover two chapters a week and are worth 20 points each. Each quiz may be taken only once. The quizzes will cover terms, concepts, procedures, and principles from the textbook. **Quizzes are to be completed by midnight every Saturday.** Since the quizzes are all available from the beginning of class, no adjustments will be made if a quiz is missed. The quiz will close out at midnight and not be accessible to the student. Quizzes are graded automatically and will post to the gradebook immediately. Be aware that some questions will need to be graded by me manually and that points will be adjusted as needed.

Discussion Posts 20pts each= 140 points total

Discussion posts will focus on applying the concepts from the textbook to determine what the student's strengths and weaknesses. **Discussion posts are to be completed by midnight every Saturday.** Published posts cannot be viewed until after their own post is made. Students must critique fellow student posts. The concepts in behavior analysis can be a challenge to understand, so if a student has an example

of a concept another student is struggling with, please post! I have not set a word limit, but I will if the posts are short and fall short of the writing expectations from that of a college attending adult.

Discussion posts will be graded as follows:

5 points	Grammar, spelling, sentence structure (you're in college, write like it)
5 points	Respectful engagement with another post
10 Points	Covers the topic of the week thoroughly (i.e. defined well, examples provided, etc)

ABA Final Paper 100pts

You will choose a topic from the textbook and write a paper no more than 3 pages long. The paper must have the following components (all in APA format):

25 points: Cover page, Body, 3 references minimum (at least 2 peer reviewed references and your textbook), Double spaced, Times New Roman, 12pt font, Page numbers, Headers

75 points: The topic you choose must be covered in following:

- Why you chose that topic
- Define what it is, pros/cons
- Provide the perspective society may have formed about that topic, if applicable, and why that is (for example positive and negative reinforcement are viewed as "good and bad" behaviors; punishment is viewed as "bad")
- Provide examples of how it utilized in today's world
- Provide examples of how you could use it in your life

Points will be deducted in increments of 0.5-1.0 for APA errors, grammatical errors, etc. Make sure to visit the Writing Center if you need help. You may visit in person or online. You are also allowed to use the Tutoring Center as well (both are in Warrior Hall). The paper will be submitted through a plagiarism site, so don't do it. Cite everything that you use from a source. Any paper that comes back with a percent higher than 30% will be examined thoroughly. If your paper is cited and the site flags it, I will not count that against you. YOU MAY TURN IT IN EARLY FOR FEEDBACK.

Drop Policy.

If you discover that you need to drop this class, you must complete a [Drop Request Form](https://www.tamuct.edu/registrar/docs/Drop_Request_Form.pdf) [https://www.tamuct.edu/registrar/docs/Drop_Request_Form.pdf].

University Library.

The University Library provides many services in support of research across campus and at a distance. We offer over 200 electronic databases containing approximately 250,000 eBooks and 82,000 journals, in addition to the 85,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place on Skype or in-person at the library. Assistance may cover many topics, including how to find articles in peer-reviewed journals, how to cite resources, and how to piece together research for written assignments.

Our 27,000-square-foot facility on the A&M-Central Texas main campus includes student lounges, private study rooms, group work spaces, computer labs, family areas suitable for all ages, and many other features.
