## **COVID-19 SAFETY MEASURES**

To promote public safety and protect students, faculty, and staff during the coronavirus pandemic, Texas A&M University-Central Texas has adopted policies and practices to minimize virus transmission. All members of the university community are expected to adhere to these measures to ensure their own safety and the safety of others. Students must observe the following practices while participating in face-to-face courses, course-related activities (office hours, help sessions, transitioning to and between classes, study spaces, academic services, etc.) and co-curricular programs:

  - o If a student refuses to wear a face covering, the instructor should ask the student to leave and join the class remotely. If the student does not leave the class, the faculty member should report that student to the Office of Student Conduct. Additionally, the faculty member may choose to teach that day's class remotely for all students.
- Physical Distancing—Physical distancing must be maintained between students, instructors, and others in the course and course-related activities.
- Classroom Ingress/Egress—Students must follow marked pathways for entering and exiting classrooms and other teaching spaces. Leave classrooms promptly after course activities have concluded. Do not congregate in hallways and maintain 6-foot physical distancing when waiting to enter classrooms and other instructional spaces.

## **COURSE INFORMATION**

### **Course Overview and description**

In this Data Structures and Algorithms course, we will learn how to analyze and implement elementary data structures and basic algorithms. This course is designed for students to have knowledge of some programming language.

### **Prerequisites:**

CIS 3340, CIS 3341, CIS 3342, or CIS 3343 must be completed before registering for CIS 3351, or receive permission from the Department Chair.

### **OR**

A programming course in C/C++, Visual Basic, Java, or permission from the Department Chair is required before registering for COSC 3351.

### **Student Learning Outcomes**

Following this course students will be able to:

1. Assess how the choice of data structures and algorithm design methods impacts the performance of programs.
2. Choose the appropriate data structure and algorithm design method for a specified application.
3. Write programs using object-oriented design principles.
4. Solve problems using data structures such as linear lists, stacks, queues, hash tables, binary trees, heaps, tournament trees, binary search trees, and graphs and writing programs for these solutions.
5. Solve problems using algorithm design methods such as the greedy method, divide and conquer, dynamic programming, backtracking, and branch and bound and writing programs for these solutions.

### **Drop Policy**

If you discover that you need to drop this class, you must complete the Drop Request Dynamic Form through Warrior Web.

On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.
