WARRIOR SHIELD

Emergency Warning System for Texas A&M University-Central Texas

Warrior Shield is an emergency notification service that gives Texas A&M University-Central Texas the ability to communicate health and safety emergency information quickly via email, text message, and social media. All students are automatically enrolled in Warrior Shield through their myCT email account.

COVID-19 SAFETY MEASURES

To promote public safety and protect students, faculty, and staff during the coronavirus pandemic, Texas A&M University-Central Texas has adopted policies and practices to minimize virus transmission. All members of the university community are expected to adhere to these measures to ensure their own safety and the safety of others. Students must observe the following practices while participating in face-to-face courses, course-related activities (office hours, help sessions, transitioning to and between classes, study spaces, academic services, etc.) and co-curricular programs:

- Self-monitoring—Students should follow CDC recommendations for self-monitoring. Students who have a fever or exhibit symptoms of COVID-19 should participate in class remotely and should not participate in face-to-face instruction. Students required to quarantine must participate in courses and course-related activities remotely and must not attend face-to-face course activities. Students should notify their instructors of the quarantine requirement. Students under quarantine are expected to participate in courses and complete graded work unless they have symptoms that are too severe to participate in course activities.
- Face Coverings— Face coverings must be worn inside of buildings and within 50 feet of building entrances on the A&M-Central Texas Campus. This includes lobbies, restrooms, hallways, elevators, classrooms, laboratories, conference rooms, break rooms, non-private office spaces, and other shared spaces. Face coverings are also required in outdoor spaces where physical distancing is not maintained. The university will evaluate exceptions to this requirement on a case by case basis. Students can request an exception through the Office of Access and Inclusion in Student Affairs.
 - o If a student refuses to wear a face covering, the instructor should ask the student to leave and join the class remotely. If the student does not leave the class, the faculty member should report that student to the Office of Student Conduct. Additionally, the faculty member may choose to teach that day's class remotely for all students.

- Physical Distancing—Physical distancing must be maintained between students, instructors, and others in the course and course-related activities.
- Classroom Ingress/Egress—Students must follow marked pathways for entering and exiting classrooms and other teaching spaces. Leave classrooms promptly after course activities have concluded. Do not congregate in hallways and maintain 6-foot physical distancing when waiting to enter classrooms and other instructional spaces.
- The university will notify students in the event that the COVID-19 situation necessitates changes to the course schedule or modality.

COURSE INFORMATION

Course Overview and Description

Rehearsal and performance of quality orchestral literature from a variety of styles. Open to any student by audition only.

Course Objective or Goal

The goal of the Orchestra is to provide each member with training and experience in ensemble playing.

Student Learning Outcomes

- Knowledge of preparation and performance of appropriate standard repertoire
- Knowledge of appropriate standard literature
- Develop collaborative skills

Materials

- Instrument
- Music. This can be found on Canvas.
- Two electronic devices, as described here:
 - device a (i.e. a computer): You will use this device to listen to a reference track through headphones while making recordings of your parts.
 - device b (i.e. a smartphone or tablet): This device should have video recording capabilities, as you will use it to record the video of you playing your part. It should also have Zoom capabilities, as you will use it for your virtual coachings.

COURSE REQUIREMENTS

Course Format

There will be no live concert or in-person rehearsals this semester. Instead, orchestra this semester will happen virtually. Students will receive individual virtual coachings on their parts over Zoom. The conductor will be emailing students about signing up for these coachings. After being coached, students will submit smartphone video recordings of themselves playing their parts. These recordings will then be compiled to create combined split-screen videos of the pieces, which will be available at the end of the semester. Instructions for recording your parts will be available on Canvas.

Practice

You are expected to come to your coachings prepared. You must learn your parts individually outside of the coachings so we can use coaching time to address musical and artistic items.

Individual practice time is different for different people. For some, 30 minutes per day is adequate. Others may need 60 minutes per day. **You** are responsible for determining the amount of practice time needed to learn your music. If you have questions about practice time or techniques, the conductor is always there to answer them.

Repertoire Recordings

These can be found on Canvas. **Listen to the recordings frequently.** Knowledge of the overall sound of a piece of orchestral music makes the orchestra sound that much better.

Attendance

For the sake of the entire ensemble, please attend your virtual coachings regularly and punctually.

Be sure to submit your recordings by the deadline. The deadline and submission instructions are listed on the recording instructions, which will be available on Canvas during the semester.

If a student absolutely must miss a coaching, there needs to be a valid excuse. An illness or a family emergency are examples of valid excuses. Homework, study groups, or work meetings are not valid excuses. **Students must email the conductor at least 2 hours in advance of the coaching for an absence to be considered excused.**

Unexcused absences will lower the final grade according to the grading system below.

Posting of Grades

Grades will be posted on Canvas.

Grading Policies

A-F. Final grades will be based on the following:

- 70% for attendance (attend all coachings)
 - One unexcused absence will lower the final grade to a B.
 - Two unexcused absences will lower the final grade to a C.
 - Three unexcused absences will result in the student being automatically dropped from the class.
- 30% for preparedness (show the conductor that you know the notes by practicing individually outside of your coachings)

Letter grades will be determined as follows:

Drop Policy

If you discover that you need to drop this class, you must complete the [Drop Request](#) Dynamic Form through Warrior Web.

Faculty cannot drop students; this is always the responsibility of the student. The Registrar's Office will provide a deadline on the Academic Calendar for which the form must be completed. University Library

The University Library provides many services in support of research across campus and at a distance. We offer over 200 electronic databases containing approximately 250,000 eBooks and 82,000 journals, in addition to the 85,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place on Skype or in-person at the library. Assistance may cover many topics, including how to find articles in peer-reviewed journals, how to cite resources, and how to piece together research for written assignments.

Our 27,000-square-foot facility on the A&M-Central Texas main campus includes student lounges, private study rooms, group work spaces, computer labs, family areas suitable for all ages, and many other features. Services such as interlibrary loan, TexShare, binding, and laminating are available. The library frequently offers workshops, tours, readings, and other events.
