WARRIOR SHIELD

COVID-19 SAFETY MEASURES

To promote public safety and protect students, faculty, and staff during the coronavirus pandemic, Texas A&M University-Central Texas has adopted policies and practices to minimize virus transmission. All members of the university community are expected to adhere to these measures to ensure their own safety and the safety of others. Students must observe the following practices while participating in face-to-face courses, course-related activities (office hours, help sessions, transitioning to and between classes, study spaces, academic services, etc.) and co-curricular programs:

- Self-monitoring—Students should follow CDC recommendations for self-monitoring. Students who have a fever or exhibit symptoms of COVID-19 should participate in class remotely and should not participate in face-to-face instruction. Students required to quarantine must participate in courses and course-related activities remotely and must not attend face-to-face course activities. Students should notify their instructors of the quarantine requirement. Students under quarantine are expected to participate in courses and complete graded work unless they have symptoms that are too severe to participate in course activities.
- Face Coverings— Face coverings must be worn inside of buildings and within 50 feet of building entrances on the A&M-Central Texas Campus. This includes lobbies, restrooms, hallways, elevators, classrooms, laboratories, conference rooms, break rooms, non-private office spaces, and other shared spaces. Face coverings are also required in outdoor spaces where physical distancing is not maintained. The university will evaluate exceptions to this requirement on a case by case basis. Students can request an exception through the Office of Access and Inclusion in Student Affairs.
 - o If a student refuses to wear a face covering, the instructor should ask the student to leave and join the class remotely. If the student does not leave the class, the faculty member should report that student to the Office of Student Conduct. Additionally, the faculty member may choose to teach that day's class remotely for all students.
- Physical Distancing—Physical distancing must be maintained between students, instructors, and others in the course and course-related activities.
- Classroom Ingress/Egress—Students must follow marked pathways for entering and exiting classrooms and other teaching spaces. Leave classrooms promptly after course activities have concluded. Do not congregate in hallways and maintain 6-foot physical distancing when waiting to enter classrooms and other instructional spaces.
- The university will notify students in the event that the COVID-19 situation necessitates changes to the course schedule or modality.

COURSE INFORMATION

Course Overview and description

This course is designed to provide individualized instruction in solo technique and repertoire for the musical performer. Prerequisite: 4 semesters of private instruction.

Course Objective or Goal

Students will explore the fundamentals of horn technique while learning strategies for peak performance through study of important solo and ensemble repertoire for the instrument.

Student Learning Outcomes

This is a performance-based course and lesson topics will depend upon each individual's experience and career goals. Each student enrolled in major lessons will prepare a minimum of one solo work each semester. Other topics of study will include tone production, breath control, rhythm, intonation, phrasing, pedagogy, orchestral excerpts, and music interpretation.

Attendance

Students are expected to arrive on time and warmed up for their scheduled lessons. Absences will be excused due to illness, family emergencies, or approved university functions. It is the student's responsibility to inform the instructor prior to the lesson if the student is going to be absent. Excused absences may be made up at a time that is convenient for the instructor. All unexcused absences will receive an "F" grade.

Furthermore, students are required to have access to a metronome and pitch-producing tuner. Students are expected to pay collaborative pianists who perform with them at recitals and juries. Also, students need to purchase any solo that they perform for a jury or a student recital. Many older works may be public domain and may be downloaded for free from imslp.com.

COURSE REQUIREMENTS

Semester grades for major lessons will be based upon the following criteria:

Lesson Preparation	50%
Midterm Jury	10%
Recital Performance	10%

Final Jury	10%
Scale Quiz	10%
Program Notes	5%
Listening Assignment	5%

Students enrolled in major lessons should be devoting a **minimum** of 10 hours a week to practicing. Those intending to pursue a career in performance should expect to practice no less than 15-20 hours per week. Students enrolled in minor lessons should be practicing at least 5 hours per week.

Lesson Preparation: Students are expected to practice assigned materials each week. Failure to thoroughly prepare assigned scales, etudes, solos, and exercises will result in a lower Lesson Preparation grade.

Recital Performance: Students enrolled in major lessons will perform on one student recital during the semester. Recital performance grades will take into consideration preparation, performance, attire, and stage presence.

Midterm/Final Jury Performances: Students enrolled in major lessons will play a jury for the faculty at the middle and end of each semester. Juries will consist of a solo work and scales consistent with student's current semester of lessons. This grade will be based upon the student's performance, as well as the recommendations of other faculty members.

Scales: Scales are essential! Students will be expected to learn all major and all minor scales by their fourth semester of lessons. Students who have passed their sophomore proficiency may (or may not at the professor's discretion) be excused from this requirement and their grades will be pro-rated without the ten percent allotment for scales.

Program notes: The student is required to prepare a minimum one-page essay on the composer and literature her or she will perform during their recital. The paper will be turned in the morning of the solo performance.

Listening assignment: Students enrolled in major lessons are expected to listen and respond to no fewer than **6** of the orchestral works listed on the handout given at the beginning of the semester. Listening assignments are due at or before the last lesson of the semester.

Posting of Grades

Grades will not be posted. The student may ask the instructor for information about his/her grade at any time.

Cell Phone Policy:

Cell phones are to remain silent and out of sight during lessons, unless they are actively being used as a practice tool (metronome/tuner/etc). If a cell phone becomes a distraction, the professor may confiscate the phone for the duration of the lesson and deduct from the student's lesson grade.

Faculty cannot drop students; this is always the responsibility of the student. The Registrar's Office will provide a deadline on the Academic Calendar for which the form must be completed. The University Library provides many services in support of research across campus and at a distance. We offer over 200 electronic databases containing approximately 250,000 eBooks and 82,000 journals, in addition to the 85,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place on Skype or in-person at the library. Assistance may cover many topics, including how to find articles in peer-reviewed journals, how to cite resources, and how to piece together research for written assignments.
