**COVID-19 SAFETY MEASURES**

To promote public safety and protect students, faculty, and staff during the coronavirus pandemic, Texas A&M University-Central Texas has adopted policies and practices to minimize virus transmission. **Course Overview and description:** Catalog Description: This course presents a broad coverage of personal financial decisions, including basic financial planning, tax issues, managing savings and demand deposit accounts, buying real assets, the use of credit, insurance, managing investments and saving for retirement.

6. Compare key long-term investments available to individuals.
7. Understand and perform time value of money calculations related to personal financial planning.
