COVID-19 SAFETY MEASURES

To promote public safety and protect students, faculty, and staff during the coronavirus pandemic, Texas A&M University-Central Texas has adopted policies and practices to minimize virus transmission.  - o If a student refuses to wear a face covering, the instructor should ask the student to leave and join the class remotely. Additionally, the faculty member may choose to teach that day's class remotely for all students.
- **Physical Distancing**—Physical distancing must be maintained between students, instructors, and others in the course and course-related activities.
- **Classroom Ingress/Egress**—Students must follow marked pathways for entering and exiting classrooms and other teaching spaces. Leave classrooms promptly after course activities have concluded. COURSE INFORMATION

Course Overview and description

Study relational database schema, formulating queries and sub-queries of varying complexity, embedding query statements in a “host” language, and defining and querying data views.

Prerequisite(s): CIS 4301 or permission of department chair.

Prerequisites:

CIS 4301 must be completed before registering for CIS 4352, or receive permission from the Department Chair.

Course Objective:

This course provides an introduction on how to use SQL to retrieve data from a database, how to update data in a database, how to build and maintain databases, how to design relational databases and strategies for displaying data after it has been retrieved.

Student Learning Outcomes:

A student successfully completing this course will be able to:

- Demonstrate the basic structure of a standard SQL query
- Write SQL statements using joins, subqueries, and built-in functions
- Write SQL statements to insert, update, and delete data
- Create views, stored procedures, functions, and triggers
- Describe the fundamentals of database design using normalization
