Course Information

Program Goal

Texas A&M University-Central Texas students, upon completion of certification requirements, will be reflective professional educators who make effective educational decisions that support the creation of dynamic learning environments.

Course Overview and Description: MUSI 4269

The purpose of this course is to introduce and advance the technical and musical skill of the performer through the individual study of classical piano literature, theory, and technique. The lessons are scheduled once per week for 60 minutes.

Technique, Skills, and Repertoire

Minimum competencies for each level of individual lessons are as follows:

Level 5 – Major Scales in all 12 major keys played two octaves, hands separately (1/8-note = mm. 80). Chords consisting of major triads, root position and inversions, hands separately. Arpeggios of major triads played two octaves, hands separately (1/8-note = mm. 72). Keyboard reading of melodies and simple two-hand textures. Transposition of melodies in major keys. Harmonization of melodies in major keys using I/IV/V7 and primary chords in lead sheet notation.

Level 6 – Scales in all 12 major keys and white-key minor key harmonic minor played two octaves, hands separately (1/8-note = mm. 80). Chords consisting of major and white-key minor triads, root position and inversions, hands separately. Arpeggios of major and white-key minor triads played two octaves, hands separately (1/8-note = mm. 72). Keyboard reading of melodies and simple two-hand textures. Score reading involving two lines for non-transposing parts. Transposition of melodies in major and white minor keys. Harmonization of melodies in major keys using I/IV/V7 and primary chords in lead sheet notation. With time permitting, other skills explored will be improvisation, playing by ear, and ensemble playing.

Level 7 – Scales in all major and harmonic minor keys played two octaves, hands separately (1/8-note = mm. 80). Chords consisting of major and white-key minor cadences, triads in root position and inversions, hands separately. Arpeggios of major and minor triads played two octaves, hands separately (1/8-note = mm. 72). Keyboard reading of 4-voice chorale textures prepared in advance. Transposition of melodies in major and white minor keys at sight, and with chordal accompaniment prepared in advance. Harmonization of melodies in major keys using I/IV/V7 at sight, and primary chords in lead sheet notation prepared in advance. Improvisation and playing-by-ear activities as time and individual abilities permit.

Level 8 – Scales in all major, harmonic minor, and melodic minor keys played two octaves, hands separately (1/8-note = mm. 80). Chords consisting of major and minor cadences, triads in root position and inversions, hands separately. Arpeggios of major and minor triads in root position played two octaves, hands separately (1/8-note = mm. 72). Keyboard reading of different textures, including score reading with varying part numbers and chorales prepared in advance. Transposition of melodies in major and minor keys at sight, and with chordal accompaniment prepared in advance. Harmonization of melodies in major and minor keys using I/IV/V7 at sight, and primary chords in lead sheet notation prepared in advance. Improvisation and playing-by-ear activities as time and individual abilities permit.

Final juries should also include technical etudes or solo compositions as assigned by their individual instructor. The individual instructors will select this music based on an individual student's current performing level.

Required Materials

All required music will be purchased by the student. Music will be assigned on the basis of individual needs.

Other Required Materials:

Pencils and a notebook for practice logs must be brought to every class meeting.

Course Requirements

Evaluation & Assessment (Grading Criteria)

The grade for this class will be based on the following: 80% will be on weekly lesson grades based on preparation for that individual lesson, 10% on Midterm Jury/Student Recital Performance and 10% on Final Jury. Each student is required to keep a notebook with their weekly lesson assignments. Students will be expected to practice at least 1 hour per day. Weekly lesson grades will be based on 3 items: attendance, promptness (this includes being warmed up for your lesson), and preparation.

Evaluation Summary

Grades will be assigned on the following basis:

A = 90 –100 represents exceptional demonstration of deep, coherent, unified understandings

B = 80 – 89.9 represents proficient overall understanding

C = 70 – 79.9 represents acceptable understanding in most areas of theory and practice

D = 60 – 69.9 represents developing understanding with some critical deficiencies

F = 59.9 < represents unsatisfactory understanding with significant deficiencies remaining

Attendance

There are no unexcused absences. The semester letter grade will be lowered one letter grade for each missed lesson. You may be excused from your lesson for illness, school activities, or family emergencies. You must inform the instructor before missing in order to be excused.

- A commitment to help you grow as a professional educator.
- Feedback in the form of graded assignments within 1 week in most cases.

Covid-19 Safety Measures

To promote public safety and protect students, faculty, and staff during the coronavirus pandemic, Texas A&M University-Central Texas has adopted policies and practices to minimize virus transmission. Students can request an exception through the Office of Access and Inclusion in Student Affairs.
- If a student refuses to wear a face covering, the instructor should ask the student to leave and join the class remotely. If the student does not leave the class, the faculty member should report that student to the Office of Student Conduct. Additionally, the faculty member may choose to teach that day's class remotely for all students.
- **Physical Distancing**—Physical distancing must be maintained between students, instructors, and others in the course and course-related activities.
- **Classroom Ingress/Egress**—Students must follow marked pathways for entering and exiting classrooms and other teaching spaces. Leave classrooms promptly after course activities have concluded. Do not congregate in hallways and maintain 6-foot physical distancing when waiting to enter classrooms and other instructional spaces.
- The university will notify students in the event that the COVID-19 situation necessitates changes to the course schedule or modality.
