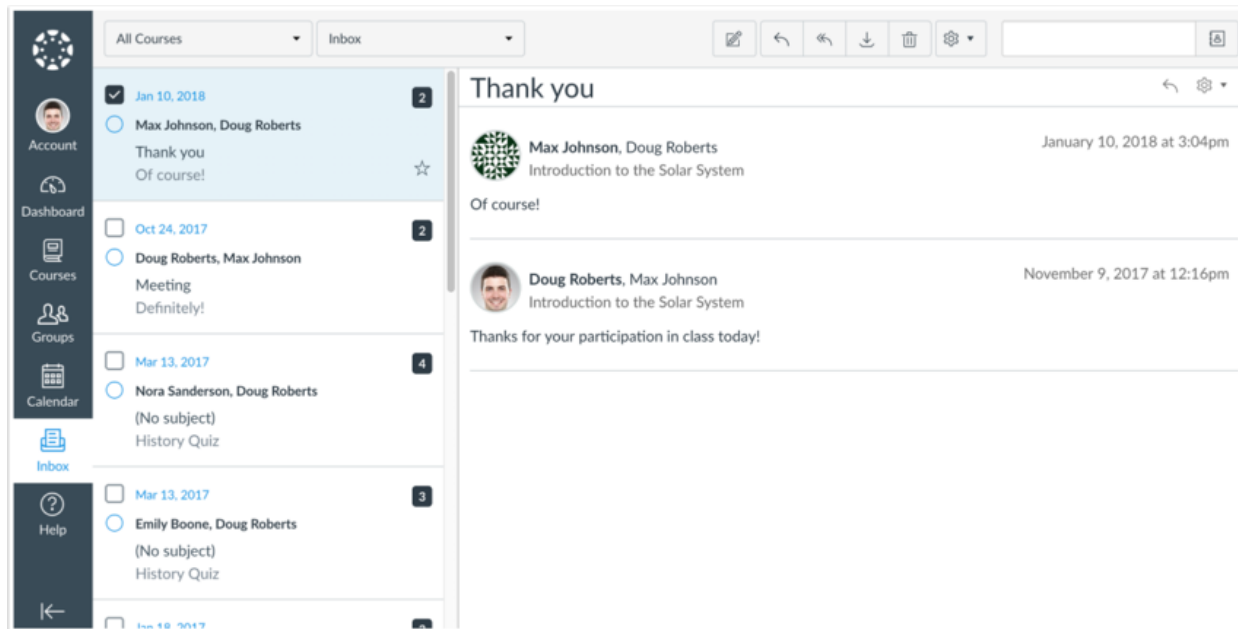

COURSE DESCRIPTION AND LEARNING OBJECTIVES

Course Description. CRIJ4316 (WI) This course presents an analysis of contemporary ethical issues in crime and justice. Classical and contemporary ethical theories will be applied to the discussion of such issues as discretion, corruption, use of force, racism, deception, professionalism, and the nature and meaning of justice. This is a writing instructive class, which means 60% or more of your grade is based on written assignments.

Course Learning Objectives. The goal of the course is to help students become familiar with some fundamental philosophies of morality and apply them to justice related issues. By the end of this course students should be able to demonstrate they understand ethics and can critically examine ethical issues in criminal justice. The objectives of the course are to,

- Demonstrate writing skills appropriate to the discipline of criminal justice.
- Demonstrate understanding and value of criminal justice ethics.
- Demonstrate understanding of the nature of justice.
- Demonstrate understanding of basic ethical theories and their application to criminal justice practice.
- Identify ethical issues commonly occurring during criminal justice operations.
- Demonstrate ability to apply knowledge and reasoning to resolving common ethical dilemmas encountered in criminal justice practice.

- Demonstrate multicultural awareness and respect for cultural diversity.

MAJOR COURSE REQUIREMENTS

Chapter Quizzes Exams (30%). The purpose of chapter review quizzes is to ensure reading and understanding of the material. Students receive limited feedback with their score, for more detailed feedback students must contact the instructor. Quizzes cover the core concepts in the book and consist of 25 questions. There are 21 quizzes, for a total of up to 525 points.

Midterm and Final Exams (30%). Exams are short answer and consist of 10-20 questions, worth up to 10 points, for a total of up to 100 points each. Short answer exams assess a student's depth of understanding. For short answer exams, students should be prepared to interpret the material in their own words.

Application Exercises (40%). Application exercises help tie ethics to real world issues and ask students to work through dilemmas by analyzing the situation through an ethical lens and applying specific moral philosophies. Submissions receive thorough feedback and the option to resubmit is available, if necessary. Check assignment instructions for specific requirements. To earn a passing grade, these assignments must conform to APA standards, be well written, and provide comprehensive answers to the question(s) posed.

GRADES

Refer to the assignment descriptions to see what % of the final grade each group represents.

90-100 A: Outstanding work and mastery of material

80-89 B: High quality work and good understanding of the material

70-79 C: Satisfactory work and basic understanding of the material

60-69 D: Minimally acceptable performance/little to no understanding of the material.

<59 F: Poor performance and does not understand basic elements of course

A C grade is average, to earn an overall grade higher than a C you must consistently produce high quality and outstanding work.

ATTENDANCE, STUDENT RESPONSIBILITIES, AND PERFORMANCE PO

Attendance. A student is attending the course if they are actively interacting with the Canvas course pages and completing assignments.

Student Responsibilities. Students are responsible for keeping up with the reading and utilizing the resources available to learn the material. Modules are organized to give students an opportunity to complete the readings and assignments in a timely manner. Each module contains slides for the chapter, chapters summaries, and additional tools for learning. Students are expected to refer to these materials and contact me for further clarification.

Other responsibilities:

- Read the assignment instructions. Failing to follow instructions will affect your scores.
- Read all of the information included with assignment instructions. There are usually helpful tips included and examples.
- Meet with a writing tutor to review your work before submitting it.
- Submit assignments on time or ahead of time.
- Review the comments I make on your submissions and contact me for more information.
- Have reliable internet access or have a backup plan to work somewhere that does.

Performance Policy. Writing is important and significantly affects scores. In general, college level writing contains no spelling and grammar errors. All information should be paraphrased unless a direct quote is necessary. Overall, writing should be concise, without losing important information, and submission should be strongly organized moving from point to point in a logical and organized manner.

Late Assignments. I generally do not accept late assignments. However, there are exceptions. Whether I accept a late assignment depends on a student's overall performance in the class. When assessing overall performance, I focus on:

- Repeated meaningful communication (i.e. to discuss course material and performance) with the instructor. This does not include requests for extensions or excuses for late submissions.
- *Demonstrated* use of all available course materials.
- Prior assignments are completed on time.

If a student's performance warrants this special consideration, the late assignment is graded once I have completed all other grading and the submission will receive limited feedback.

Drop Policy. If you discover that you need to drop this class, you must complete a [Drop Request](#)

Professors cannot drop students; this is always the responsibility of the student. Located in Warrior Hall 416, the University Writing Center (UWC) at Texas A&M University–Central Texas (TAMUCT) is a free workspace open to all TAMUCT students from 10:00 a.m.-5:00 p.m. Monday thru Thursday with satellite hours in the University Library Monday thru Thursday from 6:00-9:00 p.m. This semester, the UWC is also offering online only hours from 12:00-3:00 p.m. on Saturdays.

Tutors are prepared to help writers of all levels and abilities at any stage of the writing process. While tutors will not write, edit, or grade papers, they will assist students in developing more effective composing practices. By providing a practice audience for students' ideas and writing, our tutors highlight the ways in which they read and interpret students' texts, offering guidance and support throughout the various stages of the writing process. In addition, students may work independently in the UWC by checking out a laptop that runs the Microsoft Office suite and connects to WIFI, or by consulting our resources on writing, including all of the relevant style guides. University Library

The University Library provides many services in support of research across campus and at a distance. We offer over 200 electronic databases containing approximately 250,000 eBooks and 82,000 journals, in addition to the 85,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place on Skype or in-person at the library. Assistance may cover many topics, including how to find articles in peer-reviewed journals, how to cite resources, and how to piece together research for written assignments.

Our 27,000-square-foot facility on the A&M-Central Texas main campus includes student lounges, private study rooms, group work spaces, computer labs, family areas suitable for all ages, and many other features. Services such as interlibrary loan, TexShare, binding, and laminating are available. The library frequently offers workshops, tours, readings, and other events.
