

- The characteristics of intelligent behavior and compare the performance of natural and artificial intelligence systems.

- The components of a strategic plan.
- Goals-based strategic planning process.

COURSE REQUIREMENTS

Attendance: There will be 16 attendance requirements to be completed in the A&M-Central Texas Canvas Learning Management System. Students must log in to Canvas at least once per week. The attendance requirements are worth a maximum of 1.875 points each for a maximum total of 30 points.

Meet & Greet Discussion Forum: There will be one (1) meet & greet discussion forum to be completed in the A&M-Central Texas Canvas Learning Management System. Students must make an initial post providing a brief (about two short paragraphs) description of themselves and why they are taking the class. The Meet & Greet discussion forum is worth a maximum of ten (10) points.

Group Discussion Forums: There will be seven (7) group discussion forums. The group discussion forums will initiate with an instructor posed question. Students must make an initial post and a minimum of two reply posts to their classmates. The reply post requirement necessitates a response to two (2) different members of the class. Continued conversations beyond the minimum reply posts required are encouraged. All posts should be substantive. The group discussion forums are worth a maximum of ten (10) points each for a maximum total of 70 points.

Quizzes: There will be seven (7) quizzes to be completed in the A&M-Central Texas Canvas Learning Management System. Each quiz includes 20 multiple choice and/or True/False questions to be answered in a 50-minute timeframe. Each quiz includes two (2) attempts with the highest score recorded in the grade book. Each quiz is worth a maximum of 20 points each for a maximum total of 140 points.

Exams: There will be three (3) exams to be completed in the A&M-Central Texas Canvas Learning Management System. Each exam includes 50 multiple choice and/or True/False questions to be answered in a 125-minute timeframe. Each exam includes one (1) attempt. Each exam is worth a maximum of 150 points each for a maximum total of 450 points.

Case Study: There will be one (1) case study to be completed in the A&M-Central Texas Canvas Learning Management System. The case study has five (5) waypoints. Detailed instructions for the case study appear in Canvas. The case study is worth a maximum total across waypoints of 300 points.
