COURSE INFORMATION

Course Overview and Description

This course is designed to facilitate the development of skills, techniques, understandings, and professional dispositions which are necessary for elementary music educators. This course is designed to prepare prospective elementary music educators, public school or secular group, in both musical and non-musical aspects of being a music educator. Prerequisite(s): admission to teacher education program (MUED).

Reflect on the theories and philosophies behind music education.

Understand state and national standards for music education.

Become familiar with varied teaching approaches for elementary music education.

Synthesize a collection of elementary music education activities for use in the classroom.

Design and implement a unit of instruction (including lesson plans) appropriate for the elementary music classroom.

Gain awareness of the extramusical responsibilities of an elementary music educator.

Grades will be assigned at the end of the semester on the following basis:

C = 70 – 79.9 represents acceptable understanding in most areas of theory and practice

D = 60 – 69.9 represents developing understanding with some critical deficiencies

F = 59.9 < represents unsatisfactory understanding with significant deficiencies remaining

While tutors will not write, edit, or grade papers, they will assist students in developing more effective composing practices. By providing a practice audience for students' ideas and writing, our tutors highlight the ways in which they read and interpret students' texts, offering guidance and support throughout the various stages of the writing process. In addition, students may work independently in the UWC by checking out a laptop that runs the Microsoft Office suite and connects to WIFI, or by consulting our resources on writing, including all of the relevant style guides. Whether you need help brainstorming ideas, organizing an essay, proofreading, understanding proper citation practices, or just want a quiet place to work, the UWC is here to help!

The University Library provides many services in support of research across campus and at a distance. We offer over 200 electronic databases containing approximately 400,000 eBooks and 82,000 journals, in addition to the 96,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place virtually through WebEx, Microsoft Teams or in-person at the library. Assistance may cover many topics, including how to find articles in peer-reviewed journals, how to cite resources, and how to piece together research for written assignments.

Our 27,000-square-foot facility on the A&M-Central Texas main campus includes student lounges, private study rooms, group work spaces, computer labs, family areas suitable for all ages, and many other features.
