COVID-19 SAFETY MEASURES

To promote public safety and protect students, faculty, and staff during the coronavirus pandemic, Texas A&M University-Central Texas has adopted policies and practices to minimize virus transmission. All members of the university community are expected to adhere to these measures to ensure their own safety and the safety of others. Students must observe the following practices while participating in face-to-face courses, course-related activities (office hours, help sessions, transitioning to and between classes, study spaces, academic services, etc.) and co-curricular programs:

- Self-monitoring—Students should follow CDC recommendations for self-monitoring. Students who have a fever or exhibit symptoms of COVID-19 should participate in class remotely and should not participate in face-to-face instruction. - Physical Distancing—Physical distancing must be maintained between students, instructors, and others in the course and course-related activities.
- Classroom Ingress/Egress—Students must follow marked pathways for entering and exiting classrooms and other teaching spaces. Leave classrooms promptly after course activities have concluded. Catalogue Description:

Information is provided on managing a classroom that includes students with disabilities. Topics include creating positive interpersonal relationships in the classroom, increasing student motivation, and learning, minimizing disruptive behavior, behavioral management strategies, curriculum adaptations, crisis management, and behavior management theories. Information will also be provided on the typical characteristics associated with emotional disturbances and identification procedures.

Course Objective:

- Preservice teachers will develop skills to evaluate students’ behavior as it impacts student academic success in the classroom.
- Preservice teachers will examine the purposes for which students are evaluated for behavior intervention such as determining appropriate programing and placement for students with behavior issues according to IDEA and Section 504 of the Rehabilitation Act.

Upon completion of this course, the student will

1. develop appropriate IEP goals and objectives for students with emotional disturbances.
2. discuss ethics, laws, and rules related to implementing behavior management techniques with students with disabilities
3. describe appropriate behavior intervention techniques for use with students with disabilities.

Drop Policy

If you discover that you need to drop this class, you must complete the [Drop Request](#) Dynamic Form through Warrior Web.
