WARRIOR SHIELD

Emergency Warning System for Texas A&M University-Central Texas

COVID-19 SAFETY MEASURES

To promote public safety and protect students, faculty, and staff during the coronavirus pandemic, Texas A&M University-Central Texas has adopted policies and practices to minimize virus transmission. All members of the university community are expected to adhere to these measures to ensure their own safety and the safety of others. Students must observe the following practices while participating in face-to-face courses, course-related activities (office hours, help sessions, transitioning to and between classes, study spaces, academic services, etc.) and co-curricular programs:

- Self-monitoring—Students should follow CDC recommendations for self-monitoring. Students who have a fever or exhibit symptoms of COVID-19 should participate in class remotely and should not participate in face-to-face instruction. Students required to quarantine must participate in courses and course-related activities remotely and must not attend face-to-face course activities. Students should notify their instructors of the quarantine requirement. Students under quarantine are expected to participate in courses and complete graded work unless they have symptoms that are too severe to participate in course activities.
- Face Coverings— Face coverings must be worn inside of buildings and within 50 feet of building entrances on the A&M-Central Texas Campus. This includes lobbies, restrooms, hallways, elevators, classrooms, laboratories, conference rooms, break rooms, non-private office spaces, and other shared spaces. Face coverings are also required in outdoor spaces where physical distancing is not maintained. The university will evaluate exceptions to this requirement on a case by case basis. Students can request an exception through the Office of Access and Inclusion in Student Affairs.
 - o If a student refuses to wear a face covering, the instructor should ask the student to leave and join the class remotely. If the student does not leave the class, the faculty member should report that student to the Office of Student Conduct. Additionally, the faculty member may choose to teach that day’s class remotely for all students.
- Physical Distancing—Physical distancing must be maintained between students, instructors, and others in the course and course-related activities.
- Classroom Ingress/Egress—Students must follow marked pathways for entering and exiting classrooms and other teaching spaces. Leave classrooms promptly after course activities have concluded. Do not congregate in hallways and maintain 6-foot physical distancing when waiting to enter classrooms and other instructional spaces.
- The university will notify students in the event that the COVID-19 situation necessitates changes to the course schedule or modality.

COURSE INFORMATION

DESCRIPTION

This course is designed to give participants a challenging, stylized choral experience. We will perform a variety of literature, emphasizing the more difficult choral works. We will present a virtual concert this semester. We are open to any student by audition.

OBJECTIVE

The objective of this course is to prepare choral works for concert performances.

By the completion of this course, the student will demonstrate:

1. An awareness of rehearsal procedure.
2. Vocal competence in singing and maintaining a choral part.
3. An awareness of good choral sound and technique, and a better understanding of Musical terms, forms, phrasing, historical practices, and styles.

ATTENDANCE/ GRADING POLICY

The student is expected to attend each and every meeting of this ensemble. An absence will be recorded if the student misses more than 15 minutes of the meeting time. Two tardies will result in one absence. In case of a student's absence, the policy will be as follows:

1. More than **Two** absences will result in the student's semester grade being lowered to a **B**.
2. More than **Three** absences will result in the student's semester grade being lowered to a **C**.
4. More than **Four** absences **WILL** result in the student being **dropped** from the class automatically.
4. If the student fails to present a final recording by the due date, the student will earn an **F** for the course.

Possible reasons for absences and procedure:

2. Personal or family emergency (contact the director before the rehearsal if possible)
3. Unavoidable incidents (contact director before the rehearsal if possible)
4. If you are ill with COVID-19 and must be hospitalized or cannot sing, you will be given an Incomplete for the course, and asked to make up the missed assignments.

Music – You will be issued music by the College. You are responsible for turning in your music at the end of the semester. Music not returned will result in a fine for the replacement cost of the music.

Pencils should be used during every rehearsal for markings of breath, dynamics, phrasing, and other stylistic symbols to provide accurate interpretation of the music.

Uniforms: Long black skirt or black formal pants (not leggings or slim leg pants) with black top or black long dress (no shorter than 2" from the floor. Black closed-toed shoes (flats or heel no higher than 2"). Black socks/hosiery if visible.

Drop Policy

If you discover that you need to drop this class, you must complete the [Drop Request](#) Dynamic Form through Warrior Web.

Faculty cannot drop students; this is always the responsibility of the student. The Registrar’s Office will provide a deadline on the Academic Calendar for which the form must be completed. Once you submit the completed form to the Registrar’s Office, you must go into Warrior Web and confirm that you are no longer

University Library

The University Library provides many services in support of research across campus and at a distance. We offer over 200 electronic databases containing approximately 250,000 eBooks and 82,000 journals, in addition to the 85,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place on Skype or in-person at the library. Assistance may cover many topics, including how to find articles in peer-reviewed journals, how to cite resources, and how to piece together research for written assignments.

Our 27,000-square-foot facility on the A&M-Central Texas main campus includes student lounges, private study rooms, group work spaces, computer labs, family areas suitable for all ages, and many other features. Services such as interlibrary loan, TexShare, binding, and laminating are available. The library frequently offers workshops, tours, readings, and other events.
