#### **COVID-19 SAFETY MEASURES**

#### **COURSE INFORMATION**

### **Course Overview and description**

Study the history, development, and principles of computer operating systems and their variants in mainframe, minicomputer, server, and microcomputer application environments. Explore preferred operating systems representing various hardware environments. Special emphasis on related software issues, programming capabilities, and job control languages. Prerequisite(s): CIS 3303 or permission of department chair.

## **Course Objective or Goal**

By the end of this course, students will be able to:

- Discuss the underlying design concepts and fundamental features of popular operating systems ranging from personal computers to mainframes
- Compare the major families of personal computer operating systems (Windows and Unix)
- Discuss the organization and architecture of computers
- Identify features peculiar to mainframe computers
- Discuss the requirements and methods for process control including multiprocessing, multithreading, and concurrency
- Identify the requirements of memory management including allocation, paging, garbage collection, and security
- Identify issues and methods for managing input/output services

# **Student Learning Outcomes**

- Students should be able to measure the performance of an operation system
- Students should be able to modify the scheduling algorithms for an operating system and observe operating system performance

  words long.
- There will be five assignments each worth 10 points. Unless otherwise noted, the assignment must be turned in as a Word document report. Each document must be named with your last name followed by the assignment number (i.e. Addison Project 1.docx). These reports will be graded on spelling and grammar as well as on demonstrating that the calculations, programs, and measurements were correctly implemented. Unless you make prior arrangements, all late assignments will lose 30% of the available points before being graded. Once an assignment has been graded, it will not be graded again.
