COVID-19 SAFETY MEASURES

To promote public safety and protect students, faculty, and staff during the coronavirus pandemic, Texas A&M University-Central Texas has adopted policies and practices to minimize virus transmission. All members of the university community are expected to adhere to these

measures to ensure their own safety and the safety of others. Students must observe the following practices while participating in face-to-face courses, course-related activities (office hours, help sessions, transitioning to and between classes, study spaces, academic services, etc.) and co-curricular programs:

- Self-monitoring—Students should follow CDC recommendations for self-monitoring. Students who have a fever or exhibit symptoms of COVID-19 should participate in class remotely and should not participate in face-to-face instruction. Students required to quarantine must participate in courses and course-related activities remotely and must not attend face-to-face course activities. Students should notify their instructors of the quarantine requirement. Students under quarantine are expected to participate in courses and complete graded work unless they have symptoms that are too severe to participate in course activities.
- Face Coverings—Face coverings must be worn inside of buildings and within 50 feet of building entrances on the A&M-Central Texas Campus. This includes lobbies, restrooms, hallways, elevators, classrooms, laboratories, conference rooms, break rooms, non-private office spaces, and other shared spaces. Face coverings are also required in outdoor spaces where physical distancing is not maintained. The university will evaluate exceptions to this requirement on a case by case basis. Students can request an exception through the Office of Access and Inclusion in Student Affairs.
 - If a student refuses to wear a face covering, the instructor should ask the student to leave and join the class remotely. If the student does not leave the class, the faculty member should report that student to the Office of Student Conduct. Additionally, the faculty member may choose to teach that day’s class remotely for all students.
- Physical Distancing—Physical distancing must be maintained between students, instructors, and others in the course and course-related activities.
- Classroom Ingress/Egress—Students must follow marked pathways for entering and exiting classrooms and other teaching spaces. Leave classrooms promptly after course activities have concluded. Do not congregate in hallways and maintain 6-foot physical distancing when waiting to enter classrooms and other instructional spaces.
- The university will notify students in the event that the COVID-19 situation necessitates changes to the course schedule or modality.

COURSE INFORMATION

Course Description

Students will examine various dimensions of culture related to teaching, learning, and support services in the community. This course is a study of ethnicity, socio-economic status, language, gender, religion, age, and exceptionality as these impact teaching.

Course Outcome

Upon completion of this course, the student will be a reflective professional educator who makes effective educational decisions that support the creation of dynamic learning environments, taking into consideration the various dimensions of culture.

COURSE REQUIREMENTS

1. Sanford Inspire Professional Development Modules (3 X 10 points each = 30 points) <https://modules.sanfordinspire.org>. Create a free account using the link. Students will need to complete two assigned development modules and one self-selected module. You will upload your Module certificate as verification of completion on the assigned due date. Your assigned Modules are listed below.

Module 1: Supporting Trauma-Exposed Students

Module 2: Working Against Racial Bias

Module 3: Self-Selected

2. Chapter Discussions. (10 x 10 points each = 100 points) Students will read the assigned chapter in the course textbook and respond to the chapter prompt in the Discussion Board. Each response must be no less than 500 words, include three (3) in-text citations from the text book, address the prompt thoroughly using academic writing and follow APA 7th edition style formatting. You must post first before you can view responses. Then, students must respond to one (1) other classmate's post in no less than 100 words, include (1) in-text citation and address the response in a point/counterpoint stance. The Discussion Board rubric is located in Files.

3. Metaphor of race and ethnic diversity. (30 points). Students will analyze race as a social construct using metaphors. A variety of metaphors such as the melting pot or the tossed salad bowl have been used to define the ways by which schools should address racial and ethnic diversity. Students will generate their own metaphor that portray how schools should address this increasing diversity. The metaphor must be illustrated (by any visual representation) and described in detail what the metaphor is, what it stands for, and why it is applicable to racial and ethnic diversity. In addition, a persuasive statement must be included as to why your metaphor should be the new standard. The Metaphor rubric is located in Files.

4. Mid-Term Exam (100 points). Students will be given an exam that covers Chapters 1-5 in the textbook. Questions will be multiple choice.

5. Final Exam (100 points). Students will be given an exam that covers Chapters 6-10 in the textbook. Questions will be multiple choice.

6. Professionalism. Students are expected to attend class on time, communicate in a respectful manner, and submit graduate level work in all situations. A Dispositions Form (aligned with Texas Educator Code of Ethics TAC 145) will be completed on each student in every course of the program to assess strengths and areas of concern. Should any level of unprofessionalism occur during a course, students will be notified and complete a program Growth Plan. If the Growth Plan is not successfully achieved, the student may be asked to leave the program.

Grading Criteria Rubric and Conversion

Grades will be assigned at the end of the semester on the following basis:

Grades will be posted on the Canvas Grade book where students can monitor their status. Turn-around time for grades to be posted are within 2 weeks. Larger projects may take more time. If you have any questions or concerns, please do not hesitate to email me or make an appointment.

All assignments must be submitted on time to receive full credit. Any late assignment submitted will have an automatic 25% deduction per day or not accepted per the instructor's decision.

University Library

The University Library provides many services in support of research across campus and at a distance. We offer over 200 electronic databases containing approximately 250,000 eBooks and 82,000 journals, in addition to the 85,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place on Skype or in-person at the library. Assistance may cover many topics, including how to find articles in peer-reviewed journals, how to cite resources, and how to piece together research for written assignments.

Our 27,000-square-foot facility on the A&M-Central Texas main campus includes student lounges, private study rooms, group work spaces, computer labs, family areas suitable for all ages, and many other features. Services such as interlibrary loan, TexShare, binding, and laminating are available. The library frequently offers workshops, tours, readings, and other events.
