

HIST 5388 Problems: The Cold War

Description:

This independent readings course reviews the literature of the Cold War with a focus on the foreign policy aspects of the era.

Course Requirements:

Read ten books from the approved booklist for the course (a separate document). The following from the list must be the first three readings:

Gaddis, *The Cold War: A New History*

Westad, *The Cold War: A World History* or his earlier *The Global Cold War*

Zubok, *A failed Empire*

The writing assignment for the class is a comprehensive review of the readings, 20-30 pages in length. It should be double-spaced in 12 pnt type and submitted as an email attachment. The paper should conform to the standards in Strunk and White's *Elements of Style*. The paper should treat the standard elements of a review (style, objectivity, use of sources, thesis) while comparing the books based on common themes and approaches or schools of thought. The student will attend meetings to discuss the readings during a mutually convenient schedule during the month of July.

Grading:

The paper is worth 75% of the course grade. Participation is based on ability to discuss the readings in a detailed way, and is 25% of the grade. A point system is used based on 400 points in the class.
