## **COURSE INFORMATION**

### **Course Overview and description**

Hardware and software structures found in modern digital computers. Instruction set architecture, hardwired design of the processor, assembly language programming, microprogramming, I/O and memory units, analysis of instruction usage, and hardware complexity. Prerequisite(s): COSC 2436 or CIS 3332 or CIS 3333 or permission of department chair.

### **Course Objective or Goal**

This course provides an introduction on the nature and characteristics of modern-day computer systems.

### **Student Learning Outcomes**

Students taking this course will be able to:

1. design and simulate components with discrete logic elements.
2. draw a schematic of a basic computer system and can provide an accurate description of each element on the schematic.
3. write a simple assembler language program and explain the function of each instruction.
4. describe the internal storage format of data/information.

### **Required Reading and Textbook(s)**

“Computer Organization and Architecture” 10<sup>th</sup> ed Stallings

## COURSE REQUIREMENTS

**Examinations:** There will be two major exams, one midterm and one final exam. The exams will be taken online and will be timed. Each is worth 10 points. The midterm covers chapters 1-8 and the final covers chapters 9-16.

**Quizzes:** There will be 6 take-home quizzes. Each quiz will be worth 5 points. Quizzes are typically available on Canvas for 1 week. Each quiz is timed.

**Assignments:** There will be 6 take-home assignments. Each assignment will be worth 5 points. Assignments will typically be available on Canvas for 2 weeks. Multiple submissions are typically allowed. If an assignment has multiple files, you will be required to “zip” the files prior to submission via Canvas.

Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place virtually through WebEx, Microsoft Teams or in-person at the library. ## **University Writing Center**

University Writing Center: Located in Warrior Hall 416, the University Writing Center (UWC) at Texas A&M University–Central Texas (A&M–Central Texas) is a free service open to all A&M–Central Texas students. Whether you need help brainstorming ideas, organizing an essay, proofreading, understanding proper citation practices, or just want a quiet place to work, the UWC is here to help!
