Course Overview and description

Description. This course focuses on enunciation and transcription of the English, Latin, and Italian languages as applied to lyric diction. Familiarity with the appropriate choice of speech sounds is gained though listening, singing, and transcription assignments.

To learn and apply, through the use of IPA system, correct sounds for vowels and consonants used in lyric diction (stage and concert platform) for English, Latin, and Italian. Develop fluency in the proper pronunciation of languages using classroom drill (written, spoken, sung), worksheets, and transcriptions.
