COURSE INFORMATION

Course Overview and description

Introduction to opera genre through instruction on the preparation and production of opera performance. Study of opera history, performance practice, acting for singers. Students will obtain a better understanding of opera as an art form, a command of singing with expression and/or bringing a character to life, and an awareness of rehearsal procedure.

COURSE REQUIREMENTS

Course Requirements: (include point values for each- not just a percentage)

- **Music-** Score, as mentioned above, should be purchased or music will be provided depending on the role. Music should be learned on student's time. Students are expected to arrive to rehearsals with music prepared to the best of their ability and memorized. Staging rehearsals will be scheduled within class time if at all possible. Extra rehearsals on Fridays are included in the schedule. PLEASE make note of these and plan work schedules, etc. accordingly.
- This year students are tasked with full roles or other responsibilities all revolving around *THE MAGIC FLUTE*. You are required to attend music and staging rehearsals when called on the schedule. An absence will be recorded if student misses more than 10 minutes of a rehearsal. Students are expected to stay in rehearsal area during rehearsals and/or class meetings. If you need to leave please let Ms. Johnson know and return in a timely manner. We do not have covers (understudies) for any of the roles so you need to commit to attendance and stay healthy for the sake of the opera!
 2. A student will be allowed one excused absence during semester. (Personal illness, family emergency, unavoidable incidents) Ms. Johnson MUST be notified ASAP.
 3. Any absences after that will affect student's final grade in class and may result in the student being replaced in his or her role in the opera and being dropped from the class.
 4. If a student is absent from any dress rehearsal or performance he/she will automatically receive as F for the semester and not be allowed in the class again.
 5. **IF YOU ARE ON TIME-THEN YOU ARE LATE!!!!** 2 tardies will equal one absence.

Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place virtually through WebEx, Microsoft Teams or in-person at the library. University Writing Center: Located in Warrior Hall 416, the University Writing Center (UWC) at Texas A&M University–Central Texas (A&M–Central Texas) is a free service open to all A&M–Central Texas students. The hours of operation are from 10:00 a.m.-5:00 p.m. Monday thru Thursday in Warrior Hall 416 (with online tutoring available every hour as well) with satellite hours available online only Monday thru Thursday from 6:00-9:00 p.m. and Saturday 12:00-3:00 p.m.

Tutors are prepared to help writers of all levels and abilities at any stage of the writing process. While tutors will not write, edit, or grade papers, they will assist students in developing more

effective composing practices. By providing a practice audience for students' ideas and writing, our tutors highlight the ways in which they read and interpret students' texts, offering guidance and support throughout the various stages of the writing process. In addition, students may work independently in the UWC by checking out a laptop that runs the Microsoft Office suite and connects to WIFI, or by consulting our resources on writing, including all of the relevant style guides. Whether you need help brainstorming ideas, organizing an essay, proofreading, understanding proper citation practices, or just want a quiet place to work, the UWC is here to help!
