Drop Policy

Drop Policy If you discover that you need to drop this class, you must complete a Drop Request Form [https://www.tamuct.edu/registrar/docs/Drop_Request_Form.pdf (Links to an external site.)]. Professors cannot drop students; drops are the responsibility of the student. The Registrar's Office will provide on the University Calendar a deadline for which the form must be completed, signed and returned. INSTRUCTOR POLICIES
