#### **COURSE INFORMATION**

Course Overview and description: The purpose of this course is to provide you with a basic understanding of the connections between money, the financial system, and the broader macroeconomy. Instruction includes an overview of monetary policy and how the central bank regulates and supervises the banking system, as well as the tools it employs as it manages the cost and availability of money in the economy. With commercial banks and investment banks now virtually the same, we will examine the economics of commercial banks and investment banks, including how they are organized, the products and financial services they offer, the risks they take, why and how they are regulated, and how this has changed over time. The behavior and pattern of interest rates also are included.

Course Prerequisites: ECO 2013.

By the end of this course, you should be able to:

- 1. Appreciate how money and finance can benefit the real economy;
- 2. Understand the evolution of money and banking;
- 3. Describe how modern banks earn a profit;
- 4. Compare and contrast banks with other providers of debt finance and payments;
- 5. Understand the key sources of risk and resulting risk management decisions at banks;
- 6. Explain why financial regulations are needed and their impacts;
- 7. Describe and understand the functioning of the key money markets;
- 8. Understand the connections between short- and long-term interest rates, and the term structure of interest rates:
- 9. Describe the main policy objectives of central banks;
- 10. Examine how, by controlling interest rates, monetary policy influences inflation and unemployment;
- 11. Expalin the pros and cons of an independent Central Bank.

#### 1. Homework

There will be one (1) homework assignment for each module we cover. The solutions to the homework assignments will be posted on Connect after the due date and time. You will be graded only on the Questions and Problems that are assigned for each chapter.

Each assignment will be graded based on your performance.

#### 3. Team

Teamwork is very important. This course provides an opportunity to build teamwork skills through team activities in and after the class. Teams of 3-5 members will be assigned during our first class. You will keep this team throughout the entire semester.

## 4. Team Project & Presentation (Team: 3-5 people)

Each team will be assigned a financial institution. Students are expected to investigate the financial institution's operational structure and risk management practices with a greater emphasis on credit, liquidity, and market risks. While the relevant information can be fully found in the institution's most recent annual report, students are encouraged to explore other information sources. During the final week, the students will turn in a hard-copy of the team report and give a presentation to the class about their study. More details will be given in class.

#### 5. Exams

There will be three exams. The exams will cover materials from lecture notes, the handouts, and article discussions. Each exam will have a combination of multiple choice and essay questions. All exams are close-book & close-notes formats. You need to open your camera and will be proctored by Connect.

Exam 1 will be on 9/22 from 11:00 AM - 12:15. The exam questions will include multiple choices and fill in the blanks. For both types of questions, grading is based only on your final answer.

Exam 2 will be on 10/27 from 11:00 AM - 12:15. The exam questions will include multiple choices and fill in the blanks. For both types of questions, grading is based only on your final answer.

Exam 3 will be on 12/1 from 11:00 AM - 12:15. The exam questions will include multiple choices and fill in the blanks. For both types of questions, grading is based only on your final answer.

#### 6. Excused Absences

If you have a conflict with a scheduled exam, you MUST inform me at least one week ahead of time. There will be no make-up midterm exams, and University policy applies to final exam conflicts. If you are officially excused from a midterm exam as a result of informing the instructor, you will be able to count the final exam for an appropriate percentage of points to make up for the missed midterm exam.
