### **Course Objective or Goal**

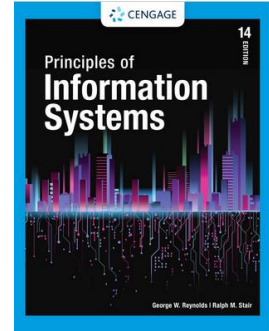

- The Internet of Things (IoT) and its applications.
- The basics of cloud computing and service models.
- The basics of internet (e/m) commerce models such as B2B, C2C etc.
- The challenges that organizations face in planning, building, and operating enterprise systems.
- The terms "business intelligence (BI)" and "analytics".
- The characteristics of intelligent behavior and compare the performance of natural and artificial intelligence systems.
- The terms virtual reality and augmented reality.
- The components of a strategic plan.
- Goals-based strategic planning process.

## COURSE REQUIREMENTS

**Meet & Greet Discussion Forum:** There will be one (1) Meet & Greet Discussion Forum to be completed in the A&M-Central Texas Canvas Learning Management System. Students must make an initial post introducing themselves to the class (noting it would be nice if you also responded to your classmates). For the Meet & Greet Discussion Forum, please only share what you are comfortable with. The Meet & Greet discussion forum is worth a maximum of five (5) points.

**Group Discussion Forums:** There will be seven (7) group discussion forums. The group discussion forums will initiate with an instructor posed question. Students must make an initial post and a minimum of two reply posts to their classmates. The reply post requirement necessitates a response to two (2) different members of the class. The Group Discussion Forums will be graded according to the Group Discussion Forum grading rubric (as it appears later in this syllabus and in Canvas). Note: The purpose of the group discussion forums is to heighten collective awareness and knowledge (noting there is no wrong answer to any question posed and further we are to respect any stated opinion). Continued conversations beyond the minimum reply posts required are encouraged. All posts should be substantive. The group discussion forums are worth a maximum of ten (10) points each for a maximum total of 70 points. Note: The group discussion forums may introduce new material (beyond the course textbook) and thus may require students to utilize established critical thinking and research skills.

**Quizzes:** There will be thirteen (13) quizzes to be completed in the A&M-Central Texas Canvas Learning Management System. Each quiz (solely based on textbook material) includes 20 questions of the multiple-choice and True/False types to be answered in a 55-minute timeframe. Each quiz includes two (2) attempts with the highest score recorded in the grade book. Each quiz is worth a maximum of fifteen (15) points each for a maximum total of 195 points.

**Exams:** There will be two (2) exams to be completed in the A&M-Central Texas Canvas Learning Management System. Each exam (solely based on textbook material) includes 50 questions of the multiple-choice and True/False types to be answered in a 125-minute timeframe. Each exam includes one (1) attempt. Each exam is worth a maximum of forty (40) points each for a maximum total of 80 points.

**Case Study:** There will be one (1) case study to be completed in the A&M-Central Texas Canvas Learning Management System. The case study has five (5) waypoints. Case Study Waypoints #1 - #4 will be graded on your ability to follow instructions and further on the developed product (completeness). All students will be afforded an opportunity to revise Case Study Waypoints #1 - #4 after the initial grading period (if they so choose). Case Study Waypoint #5 will be graded according to the Case Study Waypoint #5 grading rubric (as it appears later in this syllabus and in Canvas). Detailed instructions for the case study appear in Canvas. The case study is worth a maximum total across waypoints of 150 points.
