The exams are open book but will require you to understand the information in the chapters before attempting the exam if you are going to have time to consult your text book during the allotted time. The time allowed assumes that you have read the chapters, accomplished all of the quiz attempts and have studied for the exam sufficiently to be well prepared.

#### HELP WITH QUIZZ OR EXAM ANSWERS

If you encounter a problem which you cannot get the correct answer to, or you cannot determine the correct answer on a quiz or exam, I will be glad to help you understand the problem.

## You have 5 days to request help or challenge an answer.

Send me, via course Message, the exam or quiz number, the number of the problem you are having trouble with, the reason you chose the incorrect answer along with a reference to the page number in the text or the example you utilized in arriving at your answer. I will then be able to explain the error in your logic. The preceding method will also require you to understand why you chose the answer.

Taxation requires that you understand the material in each chapter as the material learned in each chapter may be necessary to understand succeeding chapters.

Online learning requires students to be very self-disciplined. Be sure you understand and are prepared to comply with all required class assignments and deadlines. For this course, the Weekly Assignment are posted in the syllabus in the WEEK Module in which they ae due.

# **4.3** Tax Research Paper/ Volunteer Income Tac Assistance (VITA) Participation—

<u>VITA</u> Participating in VITA allows you to gain some experience in the tax skills you have learned, help members of the community, and improve your resume. There will be an explanation of the VITA program the first day of class covering requirements and Certificates earned at the end of your participation.

## Tax Research Paper.

The Research Paper will be over a tax topic that you choose.

The paper must be prepared utilizing **APA guidelines**.

The **University Writing Center** is a good resource for writing guidance.

Paper length is between 1,200 and 1,600 words.

A short paper will be assessed a penalty of 1 point for every 2 words less 1,200.

A late penalty of 10 points per day will be assessed for late submission.

You can turn the paper in early.
