## **Course Overview and description:**

A study of key Supreme Court cases regarding civil rights and civil liberties. Students will get insight into Court decision making and be able to develop and understanding of Constitutional principles and how they relate to controversial issues.

## **Student Learning Outcomes:**

By the end of the course, students should be able to:

- 1. Identify and analyze key cases regarding civil rights and civil liberties
- 2. Comprehend the organizational processes of the judicial system and SCOTUS
- 3. Analyze majority, concurring, and dissenting opinions on key cases
- 4. Develop an understanding of Constitutional principles and apply them to controversial issues

## **Grading Criteria Rubric and Conversion**

Discussion boards will open once a week on Canvas. They will require responses to particular questions related to readings or current events. Comments must be meaningful, useful, and most importantly, respectful. Expectations for the paper are provided below. The attendance score will be reduced by 1 percentage point for each unexcused absence.

Exams will contain a mixture of question types such as short answer and multiple choice questions, the final exam is cumulative.

- > TWO (2) Opinion Critiques: 30% of final grade. Worth 300 pts (150 ea)
  - 30 pts Grammar and Formatting
  - 120pts Content

Each student will be responsible for completing two opinion critiques of **3-5 pages each.** Formatting guidelines are as follows: double-spaced lines, one-inch margins (i.e., top, bottom, left, and right), and Times New Roman font. A bibliography must be included and follow American Political Science Association Style for citations. Papers will be graded based on grammar, content, and clarity.

First, you should present the central focus of the case and its outcome. Make sure to outline what the main arguments are on either side (including the Constitutional challenge). Next critique the majority opinion. Trace the Courts logic and why you agree or disagree with key claims. Using a dissenting opinion may be helpful but use your own insights.

Grades will be posted on Canvas within a couple of days of each assignment.

Late work will reduced one letter grade for each day late. No exam will be made up without an excused absence. Make up exams are scheduled at the instructor's convenience.

The University Library provides many services in support of research across campus and at a distance. We offer over 200 electronic databases containing approximately 400,000 eBooks and 82,000 journals, in addition to the 96,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place virtually through WebEx, Microsoft Teams or in-person at the library.
