COURSE INFORMATION

Course Overview and description

This course examines selected legal, ethical, and regulatory principles and policies undergirding the American system of healthcare. The course will include the study and discussion of common law principles of liability, federal and state legislation impacting the practice of medicine, nursing, and other health professions, as well as the impact of state and federal law on the operation of health insurance plans, HMO's health clinics, and hospitals. Other topics will include patient consent, privacy, confidentiality, torts, contract law, corporate liability, malpractice, antitrust, fraud and abuse, and key federal regulations. The overarching emphasis in this course will be examining the principles needed to analyze problems and decision scenarios that may confront the CEO, CFO, or administrator working in a private or public role within a healthcare institution, managed care plan, or public agency.

Student Learning Outcomes

Upon completion of this course, students should be able to:

1. Describe the key principles and processes that form the basis of the Texas and American jurisprudence system.
2. Explain the general and specific impacts that law has on a variety of healthcare issues, such as quality, access, cost, and choice, including the powers, rights, and duties of healthcare providers, institutions, insurers, regulators, and individuals.
3. Propose resolutions of ethical issues within the healthcare environment through the application of key ethical concepts and frameworks.
4. Formulate decisions that demonstrate an understanding of the major categories of legal regulation necessary to successfully perform as a healthcare administrator.

Required Reading and Textbook(s)

COURSE REQUIREMENTS

Students are expected to engage on a weekly basis, either by attending the live session or viewing the prerecorded weekly lecture. Each lecture will be accompanied by questions intended to prompt the student in consideration of the week's topic and cases. Engagement with these prompts, and the student's response, is key to the student's grade for the course.

Grading Criteria Rubric and Conversion

Final grades will be based entirely on student participation and interaction with lecture prompts. Student are expected to submit written responses after each lecture. These responses will be discussed during the first week and are due by end-of-day on Friday of each respective week.

Grades shall be determined in the standard format (e.g., A is 89.5 and above, B is 79.5-89.4%, C is 69.5-79.4%, etc.).

Your instructor reserves the right to make modifications to the course activities to better achieve course outcomes. If any changes are needed, you will be given plenty of advance notice, and no changes will be made that result in grade reductions.

Posting of Grades

Feedback will be provided to students as needed. Final grades will be posted as soon as practicable, after the final week of the course. Should students require additional feedback, a one-on-one session can be arranged via email or phone call. Students will be advised of any edits to this policy.

Grading Policies

Whether you need help brainstorming ideas, organizing an essay, proofreading, understanding proper citation practices, or just want a quiet place to work, the UWC is here to help!

We offer over 200 electronic databases containing approximately 400,000 eBooks and 82,000 journals, in addition to the 96,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place virtually through WebEx, Microsoft Teams or in-person at the library.
