COURSE INFORMATION

Course Overview and description

This course explores and introduces pedagogical techniques and methodologies designed for and applied to teaching voice for one-on-one private teaching, class voice or choral music.

Through readings, hand-outs, lectures, presentations and other forms of observation, you will be exposed to the anatomy, physiology, acoustics and development of the human voice.

Course Objective or Goal

For the first half of the semester you will observe lessons taught by voice teachers and on the second half of the semester you will be expected to take on a student to teach for 6 weeks.

You will each be expected to use and prepare a comprehensive analysis of a specific vocal pedagogy book. Presentations on particular chapters will be assigned to each student as part of daily discussions in addition to the reading of the class textbook

Student Learning Outcomes

To have a basic understanding and knowledge of the voice using various concepts to successfully give lessons to students wanting to learn to sing.

Competency Goals Statements (certification or standards)

Throughout the semester there will be quizzes and tests covering anatomy and physiology of the voice. You will be expected to memorize and have a thorough knowledge of the breathing and throat anatomy. Other subjects covered will be phonation, articulation, registration, resonance, vocal health and maturation.

The Diagnosis and Correction of Vocal Faults by James C. McKinney.
