Course Overview and description

ENGL 3359: Literary Genres. 3 Credit Hours.

This course is an in-depth study of one major literary genre. Topics will vary and the course can be repeated for credit if taken under different emphasis. Prerequisite(s): <u>ENGL 1301</u>.

Course Objective or Goal

Literature classes aim to teach you three things: how to read a text carefully and critically, how to produce original and perceptive analyses about that work, and how to communicate those insights clearly. This course is designed to help you achieve these skills, as well as to provide you with basic knowledge about these writers' works and to foster an understanding of the ways of reading literature through a lens of gender and theory. All assignments in this course are geared toward helping you achieve these goals.

Student Learning Outcomes

- 1. Gain basic historical and cultural knowledge about the development of gender studies and gender theories as a field of study.
- 2 Analyze and critique literary and theoretical texts with the view to understanding the role gender plays in our individual and collective lives.
 - 3. Apply your gained knowledge and understanding to academic work as well as to your own lives and what you read or watch today.
 - 4. Comprehend discourses around feminism and masculinity studies.
 - 5. Develop your own opinions from deep interrogation of these issues, which you will be able support in written form throughout the course.

Required Reading and Textbook(s)

Our course will use a wide variety of texts, most of them linked into our Canvas shell by the instructor, but you will need to purchase the following texts:

This is a Writing Instructive (WI) course so writing will be an integral part of my instruction and our interactions. Writing will also be a fundamental way that I measure student mastery of course content. WI means that you will have several opportunities to work on improving your writing skills. For this course, you will work on weekly responses over our readings which will culminate in a larger final analysis paper.

COURSE REQUIREMENTS

This course makes use of many texts, including full-length films and film clips, audio, podcasts, and readings. Links to these can be found in pages section on our class homepage. Please regard each of these materials as an important part of your class research for discussions and written responses.

Weekly Discussion/Responses (60 percent of final grade)

This course has weekly discussion assignments exploring our weekly readings and reflections. These discussions offer you an opportunity to examine theories, definitions, and other texts, and to prepare thoughtful explorations and responses to the weekly readings. These are more informal written responses but should still uphold academic writing standards. Each of the six weekly responses will be worth ten points.

Presentation (15 percent of final grade)

You will choose a modern text (from the 2000s-2020s) and provide an introduction/discussion on how this text conforms to or deviates from gender stereotypes. You will create either a recorded video presentation that is 8-10 minutes long or record a podcast of equal time.

Proposal Due Date: see syllabus and assignments tab on Canvas: (5 percent of final grade)

A proposal of 250 words explaining your topic, how it relates to the material of the course, and a proposed bibliography of at **least 3 possible sources** not included on the syllabus if you are writing a research paper. If you are doing a project, explain how you are developing material from the course and bringing in new material.

Final Summative Essay (20 percent of final grade)

Our weekly responses will hopefully lead to your final summative paper (2000-2500 words), in which you will have the opportunity to examine a text of your choice against the gender theories examined over the semester, including feminist theories, masculinity theories, queer theories, cultural theories, and others from our *Theory Toolbox* text. Few, if any, text will fully align with the theories we will examine in gender studies. While many of our texts will follow these traits to a degree, they will also depart from them in a similar manner. I am interested in these alignments and departures, and so your final essay asks you to examine these consistencies and departures in a text of your choice (film, novel, short story, album). This paper is worth 20 points.

Late Work

Late Assignment Submissions Policy Discussion Board Posts

Students must submit initial discussion board postings by Thursday at midnight during the week indicated in the assignment schedule. A minimum of two response posts are required each week and must be posted by Sunday at midnight. Discussion board submissions will not be accepted for credit after the deadline.

Written Assignments

Students needing extra time may submit assignments, excluding discussion board postings, up to one week after the assignment due date. Students who submit work up to one week late will receive a penalty of 10 percent applied to the grade achieved on the late assignment regardless of the day of the week on which the work is submitted. Students who submit assignments more than one week late will receive a grade of zero on the assignment unless they have made prior arrangements with the instructor.

Exceptions

I will accept assignments more than one week late only if students have made prior arrangements with me and I agree to an extension. Students must meet the deadline agreed upon in advance with the instructor. Students who do not meet the agreed-upon deadline will receive a grade of zero on the assignment. I will accept late work without prior arrangement only in the case of extenuating circumstances (such as hospitalization, childbirth, major accident, injury or bereavement). Students who suffer such a circumstance must notify me as soon as possible of the extenuating circumstance that prevented them from submitting work on time and determine a deadline for submitting the work.
