Course Overview and description

ACCT 5375. Tax Research Seminar. 3 credits.

Develop the technical and research skills needed to address contemporary tax issues. Study tax issues, formulate research questions and develop the research skills needed to address them. Special emphasis on major tax services, evaluating relevant authorities and communicating findings in a professionally written research memorandum, familiarization of federal tax policies and procedures, and the authorities that govern tax practice.

Course Objective or Goal

A student who successfully completes the course will be able to:

- 1. Explain the sources and location of tax law and supporting interpretatively authority.
- 2. Understand the role of the tax researcher in a practical business setting.
- 3. Develop efficient tax research skills to solve sophisticated and relevant tax research scenarios by utilizing electronic research services.
- 4. Effectively communicate tax advice and the results of tax research in a professionally written research memorandum.

COURSE REQUIREMENTS

Course Requirements: (include point values for each- not just a percentage)
There will be a variety of graded and non-graded activities throughout the semester. Each activity will assess your command of the material as well as your understanding of the course goals and concepts. Activities are assigned and completed during the class period unless otherwise noted and cannot be turned in later or if classes are missed.

Weekly article review or tax memo (40%): minimum two title of articles are provided by the instructor every week; students need to search the paper from TAMUCT library database based upon the instructor provided videos. Students should pick up <u>any one of the provided articles</u> to complete the article review and answer the following questions.

- 1. Background: Who wrote the manuscript? Identify the authority/Sourcing using APA formatting.
- **2.** *Purpose:* What is the purpose, objective or intent of the research, or what are the research questions.
- 3. *Methodology:* What research methods were used (e.g., primary historical material, case studies, narratives, statistics, etc.)
- 4. Findings: Summarize the findings in your own words.
- **5.** *Implications, Limitations, and Conclusion*: Provide research contributions, limitations, and conclusions.
- **6. Future research:** list the future research if applicable.

Weekly discussion (20%): Discussion questions are based on the weekly articles (see weekly article review) provided by the instructor on Canvas, and generally are due on Wednesday at 11:59 p.m. Students pick up any one of the articles, and share your personal opinions on:

- a. Does this research ultimately contribute in any significant way to your understanding of the subject, why or why not?
- b. What are the three or four significant points you gained from the review of this research?

Mini-Project: Tax Research Progress Paper (30%) and Video Presentation (10%):

Mini project weighs heavily in this class. Each student is expected to deliver high quality research proposal and develop the manuscript. During this semester, the student will be required to provide a written and oral summary of his/her progress on the tax research manuscript (1500-2000 words).

- By the end of week 2, this summary will discuss the selected topic. Each student submitted research topics, and outlines in Canvas. The research topic will be approved by the instructor.
- By the end of week 3, a minimum of five (5) references related to the topic should be submitted.
- By the end of week 5, the draft summary will discuss the relevant literature (contents from your referred articles), references, content, and methods (if any), 500 words arounds.
- By the end of week 6, the rough draft with introductions, literature, tables, figures or graphs and implications (1000 words around).
- At the beginning of week 8, the completed draft manuscript (1500-2000 words) is submitted.
- In week 8, the video presentation (not more than 20 minutes) is required and shared on Canvas with the peers.
- See Canvas> Research Progress Paper area for detailed instructions.
- Rubric for video presentation is on Canvas.

Students are suggested the tax research topic based on their interest or from familiar areas. The following optional research topics are provided but not limited to:

- Tax credits: Earned Income Tax Credit, American Opportunity Education Credits, any other credits.
- Tax ethics issues
- Taxpayers' perceptions variance from Tax preparers' perceptions
- Small companies' tax challenges
- What challenges new immigrations face?
- Filing tax awareness...
- Tax and integration with technologies, such as data analytics, RPA...
- Or a tax case you are interested in developing...

INSTRUCTOR POLICIES

Professional-level writing and communication are critical skills in the business world. This standard should be displayed in all assignments for this class. All communications, both to the professor and student colleagues should be kept professional, including Discussion Board postings and email correspondence. For written assignments, all work should be proofread, free of grammatical errors, include proper citations, and be by American Psychological Association (APA) standards.

NOTE #1: Requests for *Incomplete Grades*: Incompletes will only be given in emergency or other extreme circumstances. The professor must approve any request for an incomplete grade in this course before the last week of classes. Where possible, requests should be submitted in written form and must include an address and telephone number where you may be contacted throughout the following semester. For a request for an incomplete grade to be considered, at least two-thirds of the coursework has to be completed. Finally, approval of an incomplete is up to the department chair.

NOTE #2: Questions concerning one's grade on a particular task (e.g., test, project) should be resolved within one week after receiving the graded material. There will not be reviewing of previously graded material at the end of the semester.

NOTE #3: Late Submissions/Resubmissions: Students have a period of 7 days each week to complete and submit the weekly assignments. Make sure to plan your time wisely and avoid last-minute submissions since no late assignments will be accepted. All assignments must be turned in by the due date unless an extension has been granted. Extensions on assignments will be considered only if they are requested at least 48 hours before the due date of the assignment under question. After the fact, extensions will not be granted. If you are sick and you know you will not be able to take a test or submit an assignment on the set due date, make sure to contact me at least 48 hours in advance.

NOTE #4: Changes to Syllabus: A syllabus serves as an instructional and study planning document for both faculty and students. Although every effort will be taken to complete the semester according to the syllabus it may become necessary to make specific changes to facilitate the academic environment better.
