COURSE INFORMATION

Course overview and description

The course analyzes financial decision-making at the corporate level with emphasis on the maximization of stockholder wealth. Students learn various topics such as financial statement analysis, the valuation of stocks and bonds, cost of capital, capital budgeting, dividend policy, leverage and capital structure, methods of firm valuation, working capital management, mergers and acquisitions, and bankruptcy.

(Prerequisite(s): ACCT 2302 or ACCT 2402 and ECON 2301. *Basic algebra, accounting, and economics required.)

Course objective and student learning outcomes

Students who successfully complete this course should be able to:

- describe the main questions pertaining to the investment and financial decisions of corporate managers in conjunction with the objective of the firm
- explain and apply the fundamental analytical tools for finance, including the conceptual foundation for the financial statements, the notion of time value of money, and the law of one price (no arbitrage principle)
- evaluate investment/financial alternatives from a time value of money perspective
- describe and apply the methods of valuing a stream of future cash flows from real assets and financial securities
- evaluate corporate investment alternatives and their risk/return characteristics
- discuss the main types of financing and their advantages/disadvantages as sources of capital

- Lecture notes/slides, problem sets, and other reading materials to be uploaded on Canvas
- A financial calculator (Texas Instrument BA II Plus) is strongly recommended.

Course requirements

- Homework assignments (150 points total)
 - Problem sets (100 points, all assignments combined)
 - Data analysis homework (**50** points) *Signature assignment linked to AACSB PSLO #6 *NOTE: Students are required to submit their homework via Canvas, using the links provided in the Assignments section of Canvas. Late submission not accepted (any extenuating circumstances should be communicated in advance).
- Exams (350 points total)
 - Exam 1 (**110** pts), Exam 2 (**120** pts), Exam 3 (**120** pts)

*NOTE: Although exams are not cumulative, you must understand earlier chapters, to be able to deal with later chapters since much of the material builds on itself.

Extra credit opportunities may be available (e.g., participation in discussion questions, career development assignments, etc.). However, any extra credit earned in this course can be used to raise students' final letter grade <u>by one notch only</u> (i.e., extra credit earned can raise the letter grade, e.g., from C to B but cannot raise it from C to A). Each case will be given careful consideration.

*Note that the limit is imposed to discourage students' "strategic" behaviors and to avoid "tail-wagging-the-dog" situations.
