COURSE INFORMATION

Course Overview and description

A study of contemporary criticism as it relates to the study of form, theory, and content of fiction, nonfiction, drama, poetry, and other artistic expression.

Course Objective or Goal

Student Learning Outcomes

Students who successfully complete this course will:

1. Develop an understanding of the foundations of twentieth-century literary theory
2. Recognize key issues in structuralist and poststructuralist theory and be able to speak to the broad difference between the two.
4. Lay a methodological foundation for their own research in literary studies.

This is a **Writing Instructive** course, which means writing will be an integral part of measuring your mastery of course content. Throughout the latter half of this course, we will shift from reading to writing, with most of the late-semester assignments aimed at assisting you in your final paper. Out of the 100 available points for this class, 80 will be connected to some form of written work. Since learning to revise your writing is fundamental to improving writing skills, we will also work on drafting, revising, and reflection.

Required Reading and Textbook(s)

- Robert Dale Parker. *How To Interpret Literature: Critical Theory for Literary and Cultural Studies*. Oxford: Oxford UP, 2014. **Do not spend over \$30 for this! (buy it used online; I will supply PDF copies for the first few meetings).**
- Catherine Belsey. *Poststructuralism: A Very Short Introduction*. Oxford: Oxford UP, 2022.

COURSE REQUIREMENTS

Course Requirements (as percentage points of final grade):

- **Reading:** This is a reading heavy-class and will incorporate a lot of readings that don't

seem all that “fun” to begin with. But we will get through them together. There are three kinds of readings: the Parker textbook (read carefully for comprehension), a few enigmatic short stories (read carefully), and primary-source theoretical readings. The latter will be tricky, and I do not expect full comprehension: the goal is to get to the gist of what these authors are about. We will be looking at the big picture (how do they think meaning enters a text broadly?). This is **not** a grad class. :)

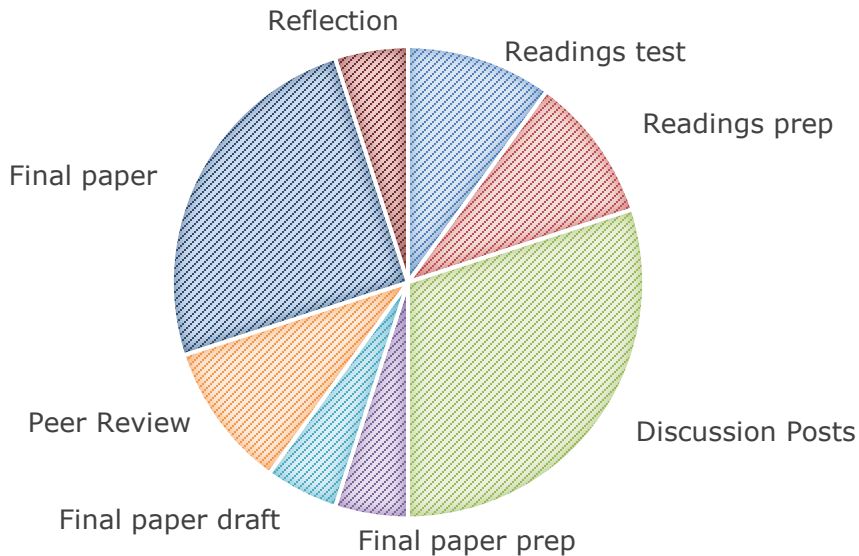
- To get credit for your fiction reading, there will be a short comprehension test (easy if you read everything, multiple choice, 10 pts total) toward the end of the semester.
- To get credit for your readings for class, I will ask you to come prepared each with a passage that puzzled or confused you—or an idea for an application or other way to illuminate the reading. I will ask you at least twice to share this prep work (low key, 5 pts each).
- **Discussion board posts** (5 pts each): Generally, Friday evening of each week, you will submit a reply (c. 2 paragraphs) to the question prompt in the respective forum. You may, but do not need to, reply to your fellow students’ posts.
- **Final Paper Proposal incl. Meeting** (5 pts): You will set up a short meeting with me to discuss your plans for the final paper. Then you will fill out the proposal form your proposal and briefly present it in class. The meeting should take place between **October 25 and November 3rd**, using my scheduling link (above).
- **Final Paper Draft** (15 pts): You will post a working draft of at least 50% of your paper (5pts) and provide meaningful feedback of at least a substantial paragraph on one of your peers’ work (5 pts each) within (note: praise by itself is not helpful).
- **Final Paper** (30 pts total): Your final paper (25 pts) will be an attempt at bringing a ‘theory’ of your choosing to bear on a text. You will be focusing on the language of the text (not characters as such) and try to leverage at least two theoretically inclined pieces of scholarship to make sense of a passage that frustrated/excited/confused you. I’m looking for 5-10 pages. You will also add a 2-3 paragraph reflection (5 pts), talking about your experience with reading and ‘applying’ theory-laden literary criticism.

[Plagiarism refers to any use of another person's work without clearly indicating its source and the extent of said use.](#)

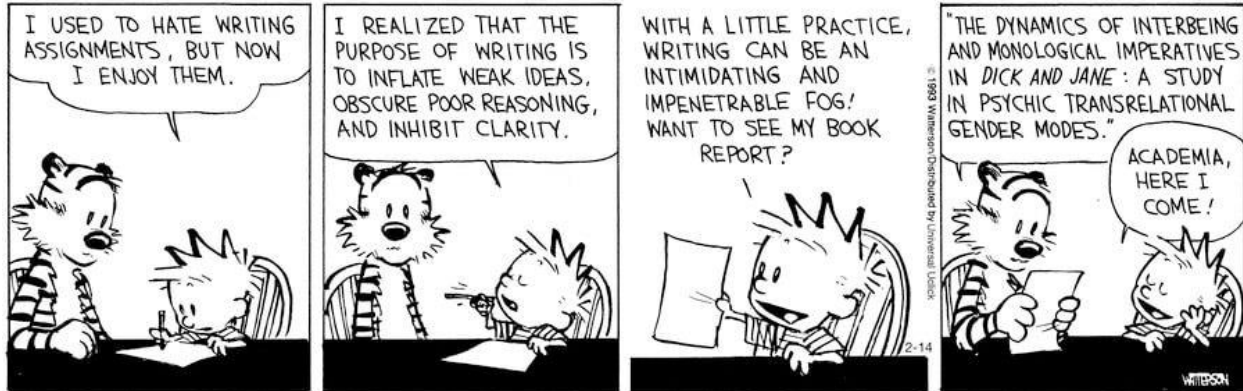
This not only includes word-by-word borrowing without attribution but also insufficient attribution (by, for instance, not using quotation marks for a direct quote), replacing single words and phrases in a copied text, paraphrasing without attribution, or AI-assisted rewriting of a source text or AI-only creation of a text. **If you are ever in doubt, I will be happy to help you avoid plagiarizing and double-check work before you turn it in.** If you are caught plagiarizing, you will fail the assignment. Repeated plagiarism (more than once) will result in failing this class. If I suspect you may have used an AI to compose your assignment, I will meet with you and quiz you on your work (i.e. can you tell me in your own words what you wrote and why?).

We offer over 350 electronic databases containing approximately 1,203,947 eBooks and 134,750 journals, in addition to the 96,879 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Located in Warrior Hall 416 and online, the University Writing Center (UWC) at Texas A&M University–Central Texas (A&M–Central Texas) is a free service open to all A&M–Central Texas students. The face-to-face hours of operation are from 10:00 a.m.-5:00 p.m. Monday and Thursday in Warrior Hall 416. Online tutoring is available Monday thru Thursday from 10:00 a.m.-5:00 p.m. and from 6:00-9:00 p.m. and on Saturdays from 12:00-3:00 p.m.

Tutors are prepared to help writers of all levels and abilities at any stage of the writing process. While tutors will not write, edit, or grade papers, they will assist students in developing more effective composing practices. By providing a practice audience for students' ideas and writing, our tutors highlight the ways in which they read and interpret students' texts, offering guidance and support throughout the various stages of the writing process. In addition, students may work independently in the UWC by checking out a laptop that runs the Microsoft Office suite and connects to WIFI, or by consulting our resources on writing, including all of the relevant style guides. Whether you need help brainstorming ideas, organizing an essay, proofreading, understanding proper citation practices, or just want a quiet place to work, the UWC is here to help!
