COURSE INFORMATION

Course Overview and Description

This methods course is concerned with providing experience for preservice educators to plan, organize, deliver, and evaluate developmentally appropriate educational strategies and instructional techniques in teaching Social Studies to diverse learners. The students design responsive instruction appropriate for all learners which reflects an understanding of relevant content, promotes active engagement, and is based on continuous and appropriate assessment. Emphasis is on integration of content.

Prerequisite: Admission to Educator Preparation Program.

Course Objectives

Upon successful completion of this course the pre-service teacher will understand and apply knowledge of social studies to create interesting, relevant, and rigorous integrated lessons.

Student Learning Outcomes:

1. Develop a comprehensive understanding of the social sciences [EC-8] and recognizing the value of social science.
2. Integrate the multiple strands of content knowledge and skills of social studies, as defined by the Texas Essential Knowledge and Skills (TEKS), with each other and with other selected disciplines in planning and implementing effective curriculum, instruction, assessment, and evaluation (unit plan)
3. Design responsive instruction appropriate for all learners which reflects an understanding of relevant content, promotes active engagement, and is based on continuous and appropriate assessment (unit-plan, quizzes, final).
4. Deliver, and evaluate, developmentally appropriate educational strategies and instructional techniques in teaching Social Studies to diverse learners (unit plan, quizzes, final).

Course Requirements/Assignments/Assessments

a. Authentic Assessment, Course Design: *Getting to Know You* Sheet (50 pts.)-

Students will complete a *Getting to Know You* sheet for themselves (25 pts.) to share with the class, as well as create a *Getting to Know You* sheet for a future classroom (25 pts.).

b. Authentic Assessment, Course Design: Chapter or Weekly Activities: You will be given weekly activities based on the chapter or resources for the week. See the module folder for directions and post as instructed by Sunday. (5@ 40pts each = **200pts**)

- Activity #1 - Discovering online resources for Social Studies
- Activity #2 - Creating a yearly plan for social studies
- Activity #3 - Creating social studies test questions using Bloom's Taxonomy and the state standards
- Activity # 4 Finding Primary Resources - you will find 3 primary resources to use with your students and give one activity for each.
- Activity #5 - Professional Growth Opportunity- Just as professional educators have the opportunity for continued professional growth, students will be given the opportunity to extend, elaborate, and apply their classroom learning by attending 1 educational experience outside of the classroom setting. Students will submit a written reflection describing the impact of the experience. These experiences will vary with the semester depending upon community and university events.

c. Authentic Assessment, Course Design: *How to Teach Historiography Skills - Nearpod* (50

pts.)- Students will design a 14-15 slide nearpod to teach students about the historiography skills of **evidence** (3 slides - introduce/share example/practice), **source** (3 slides - introduce/share example/practice), and **primary** (3 slides - introduce/share example/practice) and **secondary** (3 slides - introduce/share example/practice) sources. ****Supports the Dept. of C&I goals #3, 4, 7, Student Learning Outcomes #1-4, Social Studies EC-6 Standards II, III, & IV, and ISTE Technology Standards 1, 4, & 5.**

d. Summative Assessments: Two quizzes @ 50pts each (100 pts.)- Each student will be assessed on (1) Social Studies standards, (2) social studies/historiography skills, (3) social studies content, and other topics from the texts and research-based articles about social studies topics. ****Supports the Dept. of C&I goals #2, 6, 9, 10, Student Learning Outcomes #1, 2, 4, 5 & 6, Social Studies EC–6 Standards I, and ISTE Technology Standards 1c.**

f. Summative Assessment: An integrated unit plan for a combined Social Studies/ELAR & Wiki Visual (150)- Working with a partner/group, students will design a unit of 2-4 weeks (depends on pair/group - ex. 3 people = 3 weeks of lesson plans) that incorporates 1 non-fiction and 1 - fiction children's history books, historical thinking activities, and hands-on experiences during the unit which will also include a fine arts component. You will work together to design the unit and each of you will complete one week of lesson plans plus one assessment (rubric or test) **(100 pts.)** Then you will create a wiki together to demonstrate the unit plan in visual form to be shared with the class (50ps). ****Supports the Dept. of C&I goals #3, 4, 7, Student Learning Outcomes #1-4, Social Studies EC–6 Standards II, III, & IV, and ISTE Technology Standards 1, 4, & 5.**

g. Formative Assessment: Reading guide & Teach Lesson for identifying examples of historical context in children's literature (100 pts.) In pairs or small groups - students will practice explaining, identifying, and giving examples from children's literature for both historical context and historical significance, and then will teach a lesson to the class to demonstrate using these concepts to teach K-8 students. ****Supports the Dept. of C&I goals #3, 4, 7, Student Learning Outcomes #1-4, Social Studies EC–6 Standards II, III, & IV, and ISTE Technology Standards 1, 4, & 5.**

h. Summative Assessment: Annotated List of Children's Books Project (100 pts.)- Students will identify and annotate a list of five children's books appropriate to teaching social studies and language arts in at least three different grade levels, K-8. In the annotation you should explain what standards (ELA & SS) the book could be used for, why the book is of historical significance, how it could be used by teachers, give 2 lesson plan ideas (one SS and one ELA or integrated with both ELA/SS), and provide 2 resources to supplement the use of each book - a video, website, etc. ****Supports the Dept. of C&I Goals #2 & 7, Student Learning Outcomes #2 & 6, PPR State Standards #3, and ISTE Technology Standards #1a, 1b, 1c, 4a, 4c, 5a, 5b, 5c.**

i. Summative Assessments: Final Exam/Project (100 pts.) You will create a virtual field trip in Powerpoint or Google Slides that your students could actually use - you will post clear directions, provide the resources, and give an example of the final product students will create after visiting the field trip - a poster, brochure, essay, etc. (you create it and post as a sample for students). This will be submitted to Canvas. You must include the correct social studies standards on the first slide. **(100pts)**

j. Class Participation (50 pts.) Each student is required to participate in class through discussion, collaboration, active listening, and teaching. ****Supports the Dept. of C&I Goals #1, 2, 4, 6, 9, 10 and Student Learning Outcomes #1, 3 & 6.**

OTHER POLICIES

Class Attendance

Regular, punctual attendance, documented participation, and submission of completed assignments are expected in all classes, field experience, and other activities for which the student is registered. Failure of students to adhere to these requirements may influence the course grade, financial assistance, and/or enrollment status. Students may be excused from attendance for reasons such as health/medical reasons, family emergencies, or student participation in approved university-sponsored events. However, students are responsible for notifying their instructors in advance, when possible, for excusable absences. Whether

absences are excused or unexcused, a student is still responsible for all course content and assignments. Make-up work must be completed as soon as possible after returning from an absence.

A. Professionalism-Students are expected to attend all classes, arrive on time, sign in, and actively participate in class, including online courses. Students are expected to be professional at all times and communicate with the instructor and peers in a professional way. Any inappropriate behavior will not be tolerated and you can be asked to remove yourself from the classroom or online class at any time if you are not professional.

B. Excused Absences-You also have officially excused university days available to you that are covered under university policy- health-related issues, family emergencies, and student participation in university-related activities. Sick days and university-related activities require appropriate documentation so that any missed work may be completed.

C. Unexcused absences- If there is a situation for an absence beyond your one personal day, please communicate with your instructor. **It is YOUR responsibility to NOTIFY the instructor of your absence.**

D. Tardies- Two tardies of over 20 minutes late will count as one absence, unless there are extenuating circumstances. This is the same rule as in Clinical Practice (Student Teaching).

Mobile technology: Please turn off any mobile phones prior to the beginning of class unless we are using them to complete a class assignment. If you are expecting an important call during class time, please inform the instructor before class.

Code of Ethics for Texas Educators

The Texas educator shall comply with standard practices and ethical conduct toward students, professional colleagues, school officials, parents, and members of the community and shall safeguard academic freedom. The Texas educator, in maintaining the dignity of the profession, shall respect and obey the law, demonstrate personal integrity, and exemplify honesty and good moral character. The Texas educator, in exemplifying ethical relations with colleagues, shall extend just and equitable treatment to all members of the profession. The Texas educator, in accepting a position of public trust, shall measure success by the progress of each student toward realization of his or her potential as an effective citizen. The Texas educator, in fulfilling responsibilities in the community, shall cooperate with parents and others to improve the public schools of the community. This chapter shall apply to educators and candidates for certification.

To complete Certification/Licensing Requirements in Texas related to public education and other professional settings:

1. Candidates must undergo a criminal history background check prior to clinical teaching and prior to employment as an educator. The public-school campuses are responsible for completing the criminal background check. A person who is enrolled or planning to enroll in a State Board for Educator Certification-approved educator preparation program or planning to take a certification

examination may request a preliminary criminal history evaluation letter regarding the person's potential ineligibility for certification due to a conviction or deferred adjudication for a felony or misdemeanor offense.

A Preliminary Criminal History Evaluation is a non-mandatory, non-binding evaluation of an individual's self-reported criminal history. In addition, the agency obtains your name-based Texas criminal history information. The service is provided to the requestor for a **non-refundable fee**. The requestor will receive an evaluation letter by email from agency staff advising of potential ineligibility for educator certification.

You are eligible to request a Preliminary Criminal History Evaluation if:

- You enrolled or planning to enroll in an educator preparation program or
- You are planning to take a certification exam for initial educator certification, and
- You have reason to believe that you may be ineligible for educator certification due to a conviction or deferred adjudication for a felony or misdemeanor offense.

You are not eligible for a preliminary evaluation of your criminal history if you do not have a conviction or deferred adjudication for a felony or misdemeanor offense.

In addition, you must complete the fingerprinting process when you apply for certification. Participation in the evaluation does not preclude you from submitting to a national criminal history review at the time you apply for your educator certification. Your criminal history will be reviewed and you may be subject to an investigation based on that criminal history, including any information you failed to submit for evaluation.

Provide one of the following primary ID documents: passport, driver's license, state or providence ID cards, a national ID card, or military ID card to take the TExES exams (additional information available at www.texas.ets.org/registrationBulletin/ <<http://www.texas.ets.org/registrationBulletin/>>). YOU must provide legal documentation to be allowed to take these mandated examinations that are related to certification/licensing requirements in Texas.

Participation, Personal Responsibility and Professional Dispositions

Stay in Touch with the Instructor

Teaching well takes serious effort and commitment. You have not chosen an easy job, but you have chosen an important and rewarding job. As a teacher, you are responsible for helping students learn and grow. What you do as a teacher will make a difference in students' lives. There is much to do to prepare for taking on the demands of leading a classroom so we ask you to put in your best effort. This class will require you to stay on top of your work. If you find yourself stumbling, overwhelmed, or generally stressed out, that's a signal to get in touch with me. We will set up a time to meet or talk.

I will offer support and try to figure out how to help you balance these demands and learn so that you are prepared to teach.

Discussions

Discussions will take place with class members online, outside of class, and during class. I expect you to share your ideas, listen to and try to understand the ideas of others, ask each other questions about the topic of discussion and ideas shared, build on each other's ideas, cite examples from the texts or your experiences to support your ideas, and treat each other with respect. As a participant in discussions, do what you can to encourage your peers to participate, move the discussion forward, and make the classroom safe for different perspectives. Consider these behavioral practices and cautions to support active listening as you participate in class: Good practice includes looking at the person who is talking to you; making an effort to hear the exact words the speaker is saying; reflecting back what you hear; responding to others' ideas by extending, supporting, or challenging those ideas with your own thoughts; using specific examples from course readings to support your ideas or connect to the ideas of others; use nodding or other signs to show that what a classmate says matters. Some cautions to avoid include interrupting before the person has finished speaking, being preoccupied with other things, conveying immediate disagreement or impatience by how you look at the person, or quickly suggesting other perspectives without understanding those of the speaker.
