### **Course Overview and description**

#### **MUSI 4326/MUED 4326 . Elementary Music Methods. 3 Credit Hours.**

This course is designed to facilitate the development of skills, techniques, understandings, and professional dispositions which are necessary for elementary music educators. This course is designed to prepare prospective elementary music educators, public school or secular group, in both musical and non-musical aspects of being a music educator. Prerequisite(s) for MUED: Admission to the Teacher Education Program.

### **Student Learning Outcomes**

1. Reflect on the theories and philosophies behind music education.
2. Understand and apply state and national standards for music education.
3. Understand the key concepts, similarities, and differences of varied standard teaching approaches for elementary music education.
4. Synthesize a collection of elementary music education activities for use in the classroom.
5. Design and implement a unit of instruction (including lesson plans) appropriate for the elementary music classroom.
6. Gain awareness of the extramusical responsibilities of an elementary music educator.

### **Competency Goals Statements (certification or standards)**

Standard I. The music teacher has a comprehensive visual and aural knowledge of musical perception and performance.

Standard II. The music teacher sings and plays a musical instrument.

Standard III. The music teacher has a comprehensive knowledge of music notation.
