COURSE INFORMATION

Course Overview and description

Use C# programming language to create Windows applications in the Internet and intra-network environment. Explore object-oriented design, client-server interaction, event-driven programming, graphical user interfaces, distributed data, and distributed applications. Prerequisite(s): CIS 3330 or CIS 3331 or CIS 3332 or permission of the department chair.

Course Objective or Goal

This course provides an introduction to object-oriented programming and the C# programming language. Students will design, create, run, and debug applications. Key topics include variables, classes, objects, selection, iteration, strings, arrays, and methods.

- Design, build, execute and debug C# applications
- Use variables, arrays, strings, and file I/O
- Use flow control statements
- Use data structures
- Create graphical user interfaces

You also need to submit a screenshot showing that your code works along with the code.

Discussions: There will see many graded discussions that are worth 10 points (10%). The purpose of these discussions is to stimulate your thinking of the material presented in the class and to help you connect and learn from other students. Discussions are worth 10 points.

Term Project: There will be one term project that is worth 15 points (15%). The details will be provided in the class.
