**Course Description and Objectives:**

This course includes an analysis of relations between dominant groups and minority groups that make up American society. Theories of race relations and prejudice, the meaning of racial differences, group conflict, and modes of accommodation are emphasized. In this course students will:

- Understand why we attach meaning to race and ethnicity, including the sociohistoric constructions of race and ethnicity and contemporary socioeconomic trends.
- Understand how the idea of race changes over time and place.
- Understand the history and development of race relations in America.
- Understand the sociological concepts and theories of race and ethnic relations.

**Mode of instruction and course access:**

- . This course is 100% online and uses the A&M-Central Texas Canvas Learning Management System [<https://tamuct.instructure.com>]. CANVAS is where you will find 100% of the information related to this course, including discussions, quizzes, and exams. Monitor CANVAS for announcements every day, not just on the days things are due/assigned, since due dates occasionally may change due to unforeseen circumstances (ex: network outage).

If you feel that you will not be able to deal with this type of material, it is suggested that you drop the course now. ### **Drop Policy**

**Assignments and Grading:**

**1) Quizzes (100 points)**

**There are 5 quizzes this semester, each quiz is 10 questions worth 2 points each for a total of 20 points per quiz.**

Quizzes are multiple choice and true/false and will cover any assigned reading and video for the week they are due. You may use your book to answer the questions.

You will have 40 minutes to complete 10 questions at which time the quiz will close and you will not be able to reopen the quiz.

You must answer one question at a time and cannot go back to previous questions, so be sure of your answer before you submit each one.

Quizzes are automatically graded, so you'll know how you did immediately.

All quizzes will be based on your textbook: *Rethinking the Color Line*

**2) Check-in Assignments (100 points)**

**There are 5 check-in assignments this semester, each worth 20 points per assignment.**

You must complete the entire assignment and answer all questions to receive any points. If you do not answer all questions you will not receive any points.

Check-in assignments are designed to assess your personal experience with the concepts covered in this class. Please answer as honestly as possible and consider your answers carefully before you submit.

Think about your own life and apply the concepts you've learned in class. Consider the definition of the concepts to determine how these have applied (or not applied) in your life.

Check-in assignments will be graded based on whether you answered all questions by the deadline.

**3) Tests (100 points)**

**There are 2 tests this semester. Both are multiple choice and true/false, both are comprehensive. Each test is 50 questions worth 1 point each.**

Test 1 is subject to cover anything and everything in any assigned readings or videos since the first day of class.

Test 2 is subject to cover anything and everything in any assigned readings or videos since Test 1.

You will have 90 minutes to complete 50 questions at which time the test will close and you will not be able to reopen the test.

You must answer one question at a time and cannot go back to previous questions, so be sure of your answer before you submit each one.

Tests are automatically graded, so you'll know how you did immediately.

All tests will be based on your textbook: *Rethinking the Color Line*

**Grading:**

There are a **total of 300 points** available in this class. Final grades will be calculated depending on all points you've acquired on all assignments. All points will be added together and divided by 300 to get a percentage. I do not grade on a curve so the final percentage is your final grade. The scale below shows the percentage to letter grade comparison. If the third decimal place in the final percentage is a 5 or greater, **AND** the percentage is on the cusp of going up a letter grade, I will round up. For example, if your final percentage is .89533 (89%, B), because the third decimal place is a 5 **AND** the grade is on the verge of going up a letter, I will round up and your final grade for the class would become an A. These are the only conditions under which I will increase a final grade; all other requests will be denied.

## FAQs

### 1. What should I call you?

Email me!!!! Do this EARLY and OFTEN. I can help you understand the material, organize your notes, and give you study tips. You are responsible for your grade, but that also means you need to inform me if you're struggling so we can address issues you may be having early.

We offer over 350 electronic databases containing approximately 1,203,947 eBooks and 134,750 journals, in addition to the 96,879 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place virtually through WebEx, Microsoft Teams or in-person at the library. [Schedule an appointment here](#)

### **University Writing Center**

Located in Warrior Hall 416 and online, the University Writing Center (UWC) at Texas A&M University–Central Texas (A&M–Central Texas) is a free service open to all A&M–Central Texas students. The face-to-face hours of operation are from 10:00 a.m.-5:00 p.m. Monday and Thursday in Warrior Hall 416. Online tutoring is available Monday thru Thursday from 10:00 a.m.-5:00 p.m. and from 6:00-9:00 p.m. and on Saturdays from 12:00-3:00 p.m.

Tutors are prepared to help writers of all levels and abilities at any stage of the writing process. While tutors will not write, edit, or grade papers, they will assist students in developing more effective composing practices. By providing a practice audience for students' ideas and writing, our tutors highlight the ways in which they read and interpret students' texts, offering guidance and support throughout the various stages of the writing process. In addition, students may work independently in the UWC by checking out a laptop that runs the Microsoft Office suite and connects to WIFI, or by consulting our resources on writing, including all of the relevant style guides. Whether you need help brainstorming ideas, organizing an essay, proofreading, understanding proper citation practices, or just want a quiet place to work, the UWC is here to help!
