Some of these assignments will be related to your project and you need to integrate them at the end of the semester into your final project report. Multiple submissions before the deadline are allowed. You need to zip the files before submission if the assignment has multiple files. Before you submit any assignment, run it on your computer and make sure it works. In addition, you need to submit a screenshot to prove that your code works. Assignments are worth 80 points.
- Discussions: There will be many graded discussions that are worth 25 points. The purpose of these discussions is to stimulate your thinking of the material presented in the class and to help you connect and learn from other students.
- Final project: The final project report is the compilation of all the assignments along with some additional material as will be requested by the instructor. It is the responsibility of each student to integrate all my comments in the final document. More information will be provided on Canvas. The project report is worth 200 points.
