## **Course Overview and description**

#### HEAD 5314

This course provides an overview of the use of information technology and data analytics as they apply to healthcare, including the role of informatics within healthcare, technology environment, systems life cycle design, privacy and security, change management, and data analytics. The course will provide the student with the fundamental knowledge necessary to practice as a leader within the modern healthcare environment and communicate with information technology (IT) personnel.

- 1. Demonstrate a knowledge of Electronic Healthcare Records.
- 2. Explain the basic form and function of a technology infrastructure within the healthcare environment.
- 3. Demonstrate knowledge of system design life cycle
- 4. Demonstrate knowledge of privacy and security measures for healthcare data.
- 5. Demonstrate an ability to lead effectively, promoting change adaptation and establishing professional presence.
- 6. Demonstrate a knowledge of data analytics and demonstrate competence by manipulating raw data within excel to present in graphical format.

## COURSE REQUIREMENTS

  - *a*. Student will demonstrate competence regarding health information exchange.
  - *b.* Student will demonstrate knowledge of various aspects within technology infrastructure and identify associated terms
- 3. Demonstrate understanding of systems design life cycle.
- 4. Demonstrate understanding the importance of security and privacy as it pertains to healthcare data.
- 5. Demonstrate the understanding of the importance of leadership and management within healthcare informatics
  - a. Student will discuss the impact that change management serves specific to IT and healthcare operational workflows
- 6. Demonstrate understating of Data Analytics.
  - a. Student will be able to differentiate the different types of data analysis.
  - b. Student will demonstrate competence manipulating data within Microsoft Excel.
- 7. At the conclusion of the course, student will submit a professional presentation providing recommendations how a health system would navigate assigned challenge.
