COURSE INFORMATION

Course Overview and Description & Course Objective

This course is for the students to gain experience in marriage and family therapy by providing therapy services in approved practicum sites while under class supervision of the Marriage and Family Therapy faculty. Students should demonstrate appropriate levels of competency, assessed through direct supervision, video supervision, as well as case conference, maintaining appropriate documentation of clinical work, and meeting clinical hours requirement as described in the departmental handbook. Prerequisite(s): MFT 5301, MFT 5307, MFT 5383, MFT 5391, MFT 5392 and MFT 5393.

Intended Student Outcomes

Students will:

1. Demonstrate competence using systemic therapeutic philosophy and techniques.
2. Assess the influence of contextual issues on individual lives and relational dynamics.
3. Formulate and execute treatment plans based on individual issues, relational dynamics, and contextual issues.
4. Assess the influence of cultural background and personal experiences on case conceptualization and therapeutic intervention.

COURSE REQUIREMENTS All assignments submitted to the instructor should be a final draft, free of spelling, grammatical, stylistic, and typographical errors. Students should familiarize themselves with the supervisor's evaluation form as the basis of student's progress.

Assignments: Clinical Goals and Self Evaluation – The form is posted on Canvas. Please complete it and submit on Canvas by 5/12/23. Grade for this assignment is Pass/Fail.

Case Presentations in group setting - Each student will present a current case with written handouts. The case presentation format should follow a format based on the therapy model used (EFT, SFT, EMDR, etc). The goal of the presentation in Practicum FOUR is the practice of mentoring/supervising in anticipation of the post graduate work environment (Family Life Chaplain). The group participants will learn to identify and address strengths and growth areas of the presenting student.

Individual Supervision - Students will meet in dyads for an hour each week of individual supervision with the faculty to review cases, paperwork, and clinical performance. This will be accomplished online.

Required Paperwork - Students are required to complete clinical hour logs each week and obtain faculty and clinical supervisor's signatures. Students must complete all paperwork required by the program and department. Failure to complete required paperwork on a timely manner is unethical. (Addresses Student Outcome 1-4)

Supervisor Evaluation - The faculty supervisor will meet with students for individual or group supervision and will sign their hour logs. Both faculty and site supervisors are required to submit a TAMUCT supervisor evaluation for the student at the end of the practicum experience. Semester grade of this practicum class will depend on the faculty supervisor's evaluation. (Addresses Student Outcome 1-4)

Liability Insurance - All students must have appropriate liability insurance. Practicing without liability insurance is grounds for failing the course and disqualify from the program. Grade of this assignment: Pass/Fail In order to receive a pass of this course, students have to receive pass all assignments described above.
