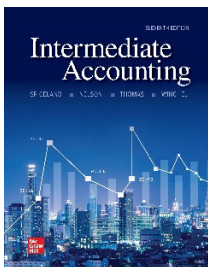
Learn accounting and financial reporting principles and practices for for-profit entities. An emphasis will be made on the FASB codification.

## **COURSE REQUIREMENTS**
